QUESTIONS TO ASK BEFORE **AGREEING TO MANDATED COVID-19 VACCINE**

1. **Are the mRNA vaccines experimental?**

Yes, every single Covid-19 vaccine has only been "authorized" by the FDA under "EUA" (emergency use authorization) except for "Comirnaty" which is simply the Pfizer BioTech vaccine renamed. It has 'supposedly' received 'full approval' on August 23, 2021 and licensing but has yet to complete the necessary process and NO actual "Comirnaty" vaccine has been manufactured and made available in the U.S.

2. **Have the vaccines been safely tested on animals?**

Animal studies were never fully completed

3. **Have they been subject to medium or long-term safety testing on humans?**

No. The earliest FDA approval will not be available until 2023.

4. **Does the vaccine have MRC-5 in it?**

Yes, they all do. MRC-5 is aborted fetal cells and other DNA. You have the right to refuse it.
