Denver will rely on the advice of its Advisor in evaluating any recommendation or proposals presented by underwriters or potential underwriters. The term "rely on" means Denver will seek and consider the advice, analysis and perspective of its Advisor; however, "rely on" does not mean that Denver must or will follow the advice of its Advisor. In the event Denver wishes to evaluate specific underwriter proposals, pitch books or ideas, Denver will forward such proposals, pitch books or ideas to the appropriate Advisor for review.
