Page Field

Located in Lee County near Fort Myers, Page Field serves a variety of general aviation activities. With its two intersecting runways, the longest of which is 6,406 feet, the airport can accommodate general aviation business jet aircraft. The airport's new state-of-the art terminal building is ideal for serving local users as well as those visiting the area.

The Lee County Port Authority manages the day-to-day operations of Page Field, in addition to providing fixed base operator services to local and transient users at the Base Operations facility in the new terminal. On-airport businesses provide air taxi/charter flights, aircraft maintenance, flight instruction, and aircraft sales. Several businesses have corporate flight departments at Page Field. The airport accommodates a significant amount of corporate and business-related traffic, emergency medical operations, general aviation charter flights, as well as recreational and flight training activity. All of the airport's tenants and flight activities are important to the airport's revenue streams and economic impact.

The annual economic impact of Page Field is associated with direct impacts that come from tenants/businesses located at the airport and construction projects that are undertaken by the airport or by on-site businesses. Indirect impacts are associated with spending from visitors who arrive in the area via general aviation aircraft.
