City of Detroit

What you are viewing is progress in the city on Garland street on the eastside of Detroit. These homes interact with the historic home of Dr. Ossian Sweet and the new Dr. Ossian Sweet Memorial Park which is located directly across the street. In 1925, when Dr. Sweet moved into his home located at 2905 Garland an enraged all white mob threw large rocks at his home breaking windows. A member of the Sweet family fired shots, killing a man. Clarence Darrow, the most famous lawyer of the era, represented Sweet and gained an acquittal from an all-white jury. For years this neighborhood suffered. (We know because the genesis of The Monthly Standard began just one block away at 3422 Garland a little over 61 years ago). Visit Garland street today and see the results. The City of Detroit's Housing and Revitalization Department's Bridging Neighborhoods team (HRD) has renovated a total of four vacant homes that are to be occupied. The addresses of the newly renovated homes are: 2912, 2918 (both pictured above) and 2924 and 2931 Garland street. These restorations unveil the history of that particular neighborhood & reveal what can be replicated throughout the city of Detroit.

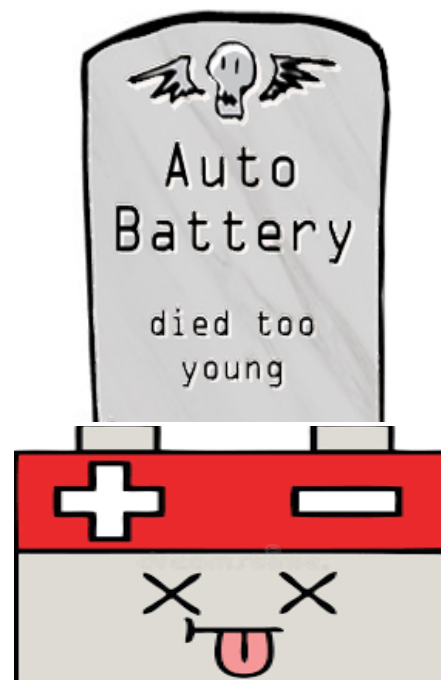
**Detroit Police Officer
Glenn Edward Smith
End of Watch: October 24, 1970**

Officers responded to a traffic complaint around 5:40 p.m. on October 24, 1970. A citizen complained they were not allowed to pass unless they accepted Black Panther literature. The officers stopped two men who had been selling the group's newspaper. A crowd gathered before the officers could issue any tickets. The scene erupted in violence and they radioed for help. Responding officers helped them arrest two men for assaulting a police officer. Before they could leave, one of the scout cars was struck by a rifle round fired by a sniper at a nearby home used by the Panthers. An injured officer was taken to the hospital and officers called for more backup. Officer Glenn Smith was among the responding officers. Around 6 p.m. Smith was standing here outside of his car when a sniper shot him in the head, killing him instantly. Officers surrounded the home and a nine-hour standoff ensued. The seven men and eight women who ultimately exited the home were charged with his murder. They were acquitted by a jury in 1971 following an 18-day trial. Officer Smith was a veteran of the U.S. Air Force. He had served the city for 2 years. He was survived by his wife, parents and siblings.



In 1970, Black Panthers congregated on Myrtle St. (now Martin Luther King) when the racist Detroit Police harassed them causing a scene. A sniper fired a shot that ironically killed black DPD Officer Glenn E. Smith.

COVER STORY

The Black Legion Terrorized Blacks, Jews, Catholics, Foreigners, and Union Organizers

The Black Legion, an offshoot of the Ku Klux Klan, began in Lima, Ohio in the early 1930's. The violent terrorist group reportedly had up to 1 million members, mostly in the small towns of West Virginia, Ohio, Indiana, Kentucky and Illinois, but the metropolis of Detroit is where the organization thrived. Upon initiation, recruits had pistols pointed at both sides of their head and their back. To become a member they had to recite this: **"Our purpose is to tear down, lay waste, destroy and kill our enemies without mercy as long as one enemy remains alive or breath remains."** After the recruit swore to the oath, he was given the password — **"Elect only members to office"** — and handed a 38-caliber gun cartridge to keep as a reminder of both his oath and what would befall him should he betray it.

Blacks were especially targeted. The Black Legion felt that any black that held a factory job was taking that job from a white man. One of many incidents against Black Detroiters is the story of George March. He was an autoworker who tried to organize black and white workers under one union. In 1935, six Black Legion members dragged George from his house in front of his wife and kids. His remains were found in a shallow grave with his hands bound with barbed wire and a bullet in his chest. No arrests were made. How could there be when police were probably a part of the crime? In Detroit, Black Legion members reportedly included the police commissioner, a third of police officers, a prosecutor, and N. Ray Markland, the mayor of Highland Park. Even Mickey Cochrane the catcher of the Detroit Tigers was said to be a member. The family of Malcolm X always felt the Black Legion killed their patriarch in 1931, in East Lansing, Michigan, and left him in the street to be run over by a streetcar. Unfortunately the hoodlums in the Black Legion terrorized the black community of Detroit, and the state of Michigan, with impunity.

In 1936, they made a fatal mistake. They killed Charles Poole a white Works Progress Administration employee who rejected membership with them. The Legion then kidnapped him and killed him because they said he was a wife beater. It was his wife (Rebecca Poole) who sounded the alarm that woke up Detroit. In May of 1936, honest cops in Detroit were put on the case and they applied enough pressure to a Black Legion member, Dayton Dean, who was already under arrest. He gave them pertinent information about the organization and multiple arrests were made. The Black Legion and its activities made national news.. Two Hollywood movies were made. (One of which, BLACK LEGION is our Movie of the Month on page 9).

Once the Detroit newspapers got a hold of the story they did not let it go. Readers sympathized for the newly widowed Mrs. Poole and her new baby. Black Legion membership plummeted. Twelve Black Legion members were convicted and imprisoned for the murder of Charles Poole effectively ending the organization. Once the onslaught began it did not stop. Even the 1935 killing of a black man was prosecuted. Five men were convicted of killing Detroiters Silas Coleman and dumping his body in Putnam Township because ringleader, Harvey Davis, wanted to see "what it felt like to kill a Negro." Dayton Dean revealed that horrific crime too.

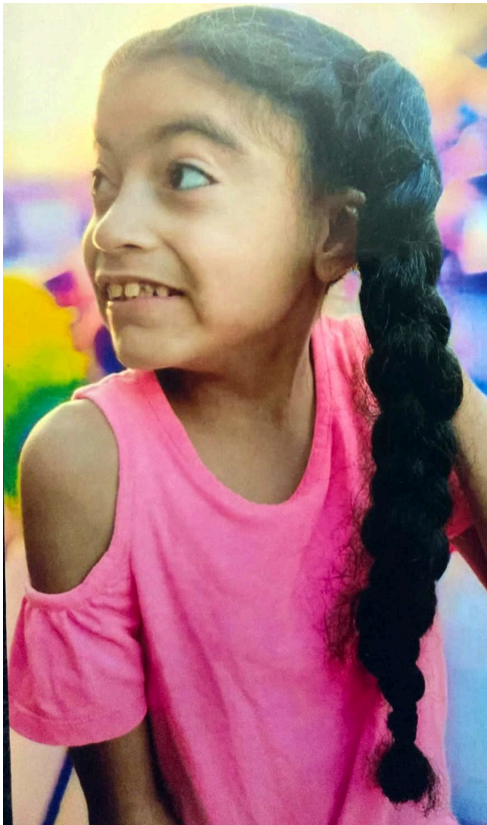

ARREST MADE IN THE MURDER OF KYLEE CLARK

The Mother of the Disabled Teen is Charged, Her Boyfriend Remains Uncharged



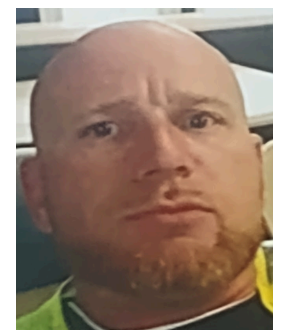

The Detroit Police Department (DPD) shocked the family of murdered teenager Kylee Clark when they arrested Vangie Averhart, and not her boyfriend Daniel Arquette. The DPD is being tight lipped and is unwilling to disclose any pertinent information concerning current, and possibly, subsequent charges. Kylee's family will have to wait until the preliminary examination of Vangie Averhart to hear exactly what evidence the DPD has compiled against her. It is unclear if the DPD's investigation of Daniel Arquette continues, or if they now look at Arquette as a witness.

Vivian Averhart the aggrieved grandmother of Kylee Clark and mother of the accused Vangie Averhart is not surprised Vangie was arrested. "Ever since she got with her boyfriend (Arquette) she would constantly say: *I don't want her.*" The grandmother (Vivian) also mentioned that her daughter (Vangie) was mentally abusive to Kylee, "Vangie would tell Kylee: *Get away from me!*" Grandma Averhart also said "when Kylee was in the hospital fighting for her life, Vangie was sound asleep while everybody else was overcome with grief." The biggest surprise for Vivian Averhart is that Vangie's boyfriend (Daniel Arquette) was not arrested too. "I know he passed a lie detector test, but he could just know how to beat the system. I don't know, but I do know a big change in Vangie occurred when he came on the scene." It's important to note when the DPD arrested Vangie she was with Arquette, sitting in his truck.

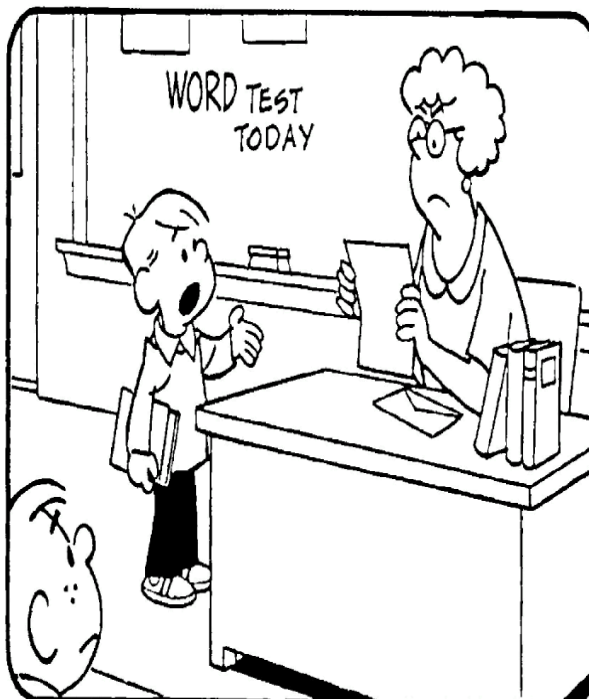
