

## Failure Was Not An Option

Failure should never have been an option.

As information comes out regarding the tragic event in Texas, there are more questions than answers. During any kind of emergency people are reacting instead of observing, because of this, information can initially be different then later developments. In the case of the Texas elementary school shooting, it appears incorrect information first released is now being responded to with anger, and it is justifiable.

Reports first shared by news media included information about an armed SRO on site who came in contact with the man but failed to stop him. Other reports stated that a shootout with law enforcement officers took place before he entered the school. More reports incorrectly stated that the shootings took place outdoors. One report stated that he was being chased by law enforcement for shooting his grandmother, crashed his truck and they entered the school building. The police believed it was a barricade situation and not an active shooter.

All the above statements are now reported to be wrong.

What is being reported now and backed up in many cases by video, is that law enforcement officers failed to enter the building upon notification of the shooter. Parents who screamed for their children to be rescued were handcuffed and placed on the ground. The rear entrance of the school was not secured and video shows the man, holding a rifle, rounding the back of the school and entering the door.

An 11 year old survivor has come forward with her story, hoping to share some truths about the great failure that may have cost her classmates and teachers their lives.

While watching a movie, the child and her teacher heard gunshots in the building. Before her teacher could reach and lock their door, the gunman was there. After he entered the room he shot the teacher and some of the students. After the gunman left her classroom, she located her teacher's phone and called 911. After the call she resorted to a survival tactic that worked. Using the blood of a friend, she covered herself to appear wounded and played dead. The little girl believed the police would be there to rescue her right away, but unfortunately that wasn't the case. It would take more than 30 minutes for anyone to enter the building in an attempt to stop the shooter and rescue her.

After the tragic events at Columbine, where law enforcement waited for a swat team that wasted precious minutes, it was determined that the approach to any event like this would be to immediately enter the premises and stop the threat. So, what happened? Were none of the law enforcement officers on scene trained for such an emergency event? Were there no officers on site trained for combat? Where was the training? Why was there no SRO officer at the school and why was the back door unlocked and accessible to anyone?

There is no excuse for the failures that took place.

All schools in our country should have emergency plans and safety devices in place. All doors should have braces and secured locks. Front entrance glass and exterior doors should have metal inlaid to prevent easy access.

Camera systems, monitored from a manned desk, should include interior and exterior cameras. Ring cameras offer the ability to listen and speak through their devices. Suspicious people and vehicles should be reported to security immediately.

Panic buttons should be accessible in hallways and classrooms.

Classrooms should be equipped with wall mounted canisters of defense spray. Protocols should be in place to evacuate

everyone in ground level rooms through windows or exterior doors.

While school is in session, all exterior doors should be locked and only opened from the inside or with a buzzer or code.

Law enforcement and school officials, especially SROs, should receive on-site emergency training no less than twice a year, that includes "under stress" activities. SRO's should be fit, healthy and capable of handling combat situations and need to understand that part of their job is to run toward the danger to stop it.

No parent should ever be handcuffed and detained when a lack of law enforcement activity is evident. No law enforcement officer should ever be sitting and waiting if the opportunity to stop the threat is there. No gunman should ever be allowed to frequent multiple classrooms, shooting innocent victims, over a period of 30 minutes or more anywhere in the USA.

That is unacceptable. That is a clear failure. Procedures and training need to start today and need to be part of standard practice of training for every law enforcement agency and school system.

Failure is not an option.

#### **Topsail Gun Gal: Welcome To The 21st Century**

The State of Maryland has approved the use of digital ID through the "Apple Wallet" app. A Maryland resident may now show their Driver's License and state ID by showing their phone and displaying the information. The law still requires the residents to keep a hard copy on their person in case their phone fails to work properly. Major airports, such as Baltimore/Washington and Ronald Reagan Washington National Airport are on board and hope to add more airports to the list.

Since the rest of our life is on these handheld computers doesn't this make sense all around? Wouldn't it be nice if North Carolina joined the movement so that a Driver's License, Conceal Carry Permit and store discount cards could all be in your hand? Come on North Carolina, it's 2022.

The North Carolina Bar Owner's Association (drinking not legal) is asking the North Carolina ABC Board to get into the "now" by removing outdated "draconian" laws. North Carolina is one of 17 states that has full control over the sale and distribution of alcoholic products and oversees all beer and wine sales. The state currently has a "membership" requirement for establishments that have less than 30% of their sales in food and non-alcoholic beverages. This means that people who enter a bar are supposed to sign in and get a membership card. A person who goes into a restaurant doesn't have to do any of these things. The idea that a bar needs to "know their clientele" is very outdated and needs to go. The next topic being presented during the short session

this May is allowing "Happy Hour". The ABC board states that no item shall be given a special time slot for sales and any item discounted must be done "all day".

The restrictions against advertising need to be updated as well. Currently no establishment can advertise any product outside their building. All advertising must be indoors.

The fact that businesses cannot purchase outside of North Carolina causes undue stress. Products available in other states cannot legally be purchased and sold within the state unless it comes from the ABC warehouses. Currently, the size and manpower provided by the warehouse is insufficient to supply all the businesses and a push is underway for a new, larger and more modern facility to be built.

During a workshop of the Surf City Council a decision was made that has raised a few questions. A statement was released that the "adopt-a-beach access" program was being canceled. This program is a completely volunteer program started in 2019 that allowed businesses, non-profit and private citizens the opportunity to help keep Surf City beach accesses clean and safe.

Not only were the accesses kept clean, but monthly reports were submitted regarding any repairs or issues presented. This sounds like a win-win for both the town and the community. So why the decision? A petition has been started that is requesting signatures to present to the town to reinstate this program.

Remember, knowledge is power and happy hour is nice.



#### **Sea Turtle Hospital News**

We talk to our turtles all the time, and they generally respond to the sound of our voices. In all honesty they're probably only paying attention to us because they think we're there to deliver a meal. But what can turtles really hear. especially underwater where they do most of their hearing? Since last year some of our patients have been participating in non-invasive research to find answers to that very question.

The project is being conducted by our turtle vet, Dr. Craig Harms along with Charles Muirhead PhD student (Duke) and Wendy Dow Piniak, PhD (NOAA) with funding from the Bureau of Ocean Energy Management (BOEM.) The ocean is a noisy place with naturally occurring sounds including storms and hurricanes. But there's also a lot of people noise from commercial, recreational and military activity. Our proximity to Lejeune has desensitized us locals to the "sounds of freedom" but how are sea turtles responding to Coast Guard boats, ordnance and low flying aircraft?

The research is designed to determine what thresholds sea turtles are most sensitive to; what's the quietest sound they respond to at each frequency (or as a musician would call it, "pitch"). It's important to remember that our turtles are not harmed in any way. The method used is the "Auditory Evoked Potential"

(AEP) method, the same one employed to evaluate hearing in babies and nonverbal patients and involves attaching external sensors that measure brain activity. We use our surgical room for the study as it is the quietest spot in our hospital. A large tank of water is rigged with an underwater speaker and a platform where the turtle is secured then lowered and raised in the water as the sounds change. It requires some swaddling of the flippers with additional restraint of a bag for the feisty turtles.

There's quite a bit of specialized electronics involved to generate sounds and record data. The equipment is so sensitive that we have to tiptoe around the building as even the sound of a door opening and closing anywhere near the surgery can contaminate the data. Each turtle spends about an hour in the tank to get enough clean readings.

The research is ongoing. Obviously only our smaller turtles can participate and despite their reputation the Kemp's have been the most compliant. The greens - they definitely need the bag. It's pretty cool research and if I were a turtle I'd raise my flipper to volunteer.

Nesting season has officially arrived, and our Topsail Turtle Project volunteers are out on the beaches before sunrise looking for signs that mama has nested. As of this writing we have two verified nests on the island. If you spot a nesting mama, or anything unusual such as an injured or stranded turtle please call our Director of Beach Operations, Terry Meyer at: 910-470-2880. If she is not available, you may call the hospital during operating hours: 910-329-0222. We will take the information and we will send a trained volunteer to meet you to assess the situation. The State of NC. hotline for stranded, sick, and injured turtles is 252-241-7367. The state number picks up 24/7. Please note that all our work with sea turtles, at the hospital and on the beach, is authorized by the NC Wildlife Resources Commission, ES



## Surf City Police Department Joins ICAC Task Force and Receives \$35k Grant

Surf City, NC, Wednesday, May 20, 2022

In an effort to increase resources that assist with investigations, the Surf City Police Department has become a member of the North Carolina Internet Crimes Against Children (ICAC) Task Force.

The ICAC Task Force helps Federal, State, and local law enforcement agencies enhance their investigative responses to offenders who use the Internet, online communication systems, or computer technology to sexually exploit children. The Program is funded by the United States Department of Justice, Office of Juvenile Justice, and Delinquency Prevention. The ICAC Program is a national network of 61 coordinated task forces representing over 5,400 federal, state, and local law enforcement and prosecutorial agencies that are engaged in proactive investigations, forensic investigations, and criminal prosecutions.

The Surf City Police Department was awarded \$35,000 by the ICAC to cover the cost of equipment and training to

better prepare and equip our officers in the fight against child predators. The grant covers the cost of the hardware, software, and training for equipment needed to effectively investigate crimes against children and was awarded in conjunction with the Police Departments joining the Internet Crimes Against Children Task Force. The Surf City Town Council voted unanimously on May 20, 2022, to accept the grant award.

"Due to the increase in investigations of crimes against children, we began seeking assistance from outside agencies for technology that would allow us to seek and preserve evidence in these critical cases. This need led us to the North Carolina Internet Crimes Against Children (ICAC) Task Force which opens investigative opportunities for our detectives giving them resources that, as a small agency, may not have been economically feasible or available. After joining the task force, we are excited to announce that we've been awarded an ICAC grant that will enable

us to effectively investigate and prosecute those responsible for perpetrating crimes against children. The grant will specifically allow us to obtain some critical capital equipment and broaden our investigative capabilities and productivity of our officers. We look forward to working with our Federal, State, and local partners to better serve our residents and keep our children safe." - Chief Phillip J. Voorhees



#### **Know NC Gun Laws and Rules**

1. A person must be 18 years of age to purchase a long gun that includes rifles and shotguns. A photo ID and a background check is required by any NC gun shop before transferring this weapon to a buyer. If a person is 21 or older, and has a NC Conceal & Carry permit, then no additional background check is required.

- 2. A person must be 21 years of age or older to purchase a handgun. In order to purchase a handgun, the NC resident must have a photo ID and a NC Purchase Permit or NC Conceal Carry permit.
- 3. A person who holds a Conceal & Carry permit from another state may legally carry concealed in NC but cannot purchase and leave with the handgun in NC.
- 4. A person who is 18 through 20 years of age may obtain a purchase permit from their sheriff's office to purchase or receive a handgun from a private person such as a family member. These permits are not valid to purchase from a licensed FFL gun dealer.
- 5. A person on vacation may purchase a handgun and it will be shipped to a gun dealer in their state for pickup.
- 6. Any person may ship a firearm as long as a copy of their photo ID is included in the box and it MUST be received by an FFL. It is against the law in all states to ship firearms to a private person.
- 7. Both a NC purchase permit and conceal carry permit are good for 5 years. A conceal carry permit is renewed every 5 years for a fee. If the conceal carry has not expired, no additional classes are required.
- 8. A NC purchase permit can not exceed 5 dollars in cost and there is no limit to the number of permits a person can get.
- 9. Before travelling out of state with a firearm, make sure you know every state's laws that you will travel through. Call local gun shops in those states.
- 10. Firearms must be locked and out of reach of children and any one who is not allowed to access them.
- 11. 99% of all firearms are semi-automatic which means one pull of a trigger per bullet.
- 12. Full auto weapons require extensive paperwork, fees and background checks. Full auto weapons are very expensive.
- 13. It is legal to hunt in Pender County with a suppressed firearm.
- 14. A silencer or suppresser does not make the gun 100% quiet but does dampen the noise.
- 15. A person may not fire a firearm within city limits and should check with their local county for firearm regulations.

#### Ten Rules of Safe Gun Handling

- 1. Always keep the muzzle pointed in a safe direction and away from people. Never point your gun at anything you don't intend to shoot.
- 2. Firearms should be unloaded when not in use. Always make sure the magazine is out of the gun and no live round is in the chamber.
- 3. Don't rely on your gun's "safety". Always treat a gun as if it could fire at anytime.
- 4. Be sure of your target and what is beyond it. A pile of dirt or clay will not let a bullet travel through. A wooden target will not stop a bullet.
- 5. Use correct ammunition. Avoid reloaded ammo unless you personally know where it came from and trust that person.
- 6. If your gun fails to fire when the trigger is pulled, handle with great care! Keep gun pointed at a safe direction and unload firearm.
- 7. Always wear eye and ear protection when shooting.
- 8. Be sure the barrel is clear of obstructions before shooting.
- 9. Clean your gun and inspect it regularly.



#### Simply Homemade Recipes

### Good Old Fashioned Pancakes



1-1/2 cups all-purpose flour 3-1/2 teaspoons baking powder

1/4 teaspoon salt, or more to taste

1 tablespoon white sugar

- 1-1/4 cups milk
- 1 egg
- 3 tablespoons butter, melted

In a large bowl, sift together the flour, baking powder, salt and sugar. Make a well in the center and pour in the milk, egg and melted butter; mix until smooth. Heat a lightly oiled griddle or frying pan over medium-high heat. Pour or scoop the batter onto the griddle, using approximately 1/4 cup for each pancake. Brown on both sides and serve hot.

#### Rack of Lamb with Strawberry Mint Sauce



Lamb:

1 (8 bone) rack of lamb, fully trimmed kosher salt to taste freshly ground black pepper to taste cayenne pepper to taste 2 tablespoons Dijon mustard

2 tablespoons Dijon mustard 1 tablespoon finely minced green onions 1/4 cup fine plain bread crumbs 2 tablespoons melted butter 1/4 teaspoon salt

Sauce:

2 cups fresh strawberries, hulled and halved

1 lemon, zested and juiced

1 lemon, juiced

1/4 cup water

2 tablespoons honey

salt and cayenne pepper to taste 1/4 cup freshly sliced mint leaves

Place halved strawberries, zest from one lemon, juice from 2 lemons, water, honey, salt, and cayenne pepper in a pot over medium-high heat and bring to a simmer. As strawberries begin to release their liquid, soften, and start to break down, reduce heat to medium-low and continue stirring and cooking occasionally until fruit is very soft, about 10 minutes. Remove from heat. Pass mixture through a fine mesh strainer. Preheat oven to 475 degrees F (245 degrees C). Line a shallow baking pan with foil, bringing ends up and over sides of the pan. Generously season rack of lamb on both sides with kosher salt, freshly ground black pepper, and cayenne pepper. Place lamb on prepared pan. Roast rack of lamb in hot oven to sear, about 10 minutes. Remove pan from oven. Reduce oven temperature to 375 degrees F (190 degrees C). Preheat oven to 375 degrees F (190 degrees C). Combine mustard and onions in a small bowl. Pour melted butter into bread crumbs in a separate bowl; stir until mixture resembles wet sand. Season with salt. Coat top of lamb generously with the mustard mixture. Sprinkle crumb mixture onto the mustard mixture and press down to create a crumb crust. Roast rack until it reaches an internal temperature of 125 degrees F (50 degrees C), about 15 minutes. Let rack rest 10 minute before slicing between ribs into four 2-rib servings or two 4-rib servings. Mix thinly sliced mint into strawberry sauce just before serving. Spoon a small pool of the sauce onto serving plates. Place ribs on sauce to serve.

Hello,


I usually don't complain but I think this is terrible. I got the tax bill for my home in Pender County extremely late - county was late not me and I started making payments that I could afford to keep up with.
