North Carolina Homeowners Could Face Insurance Increases Between 42% And 99%

North Carolina Insurance Commissioner Mike Causey announced the North Carolina Rate Bureau filed with the NC Department of Insurance asking for an average statewide increase in homeowners' insurance of 42.2% with amounts as high as 99% in coastal areas. The Rate Bureau has asked that the rate increase begin August 1, 2024.

Property owners throughout North Carolina are outraged. With cost-of-living increases felt with food, services, taxes and fuel, the section of the population living on a fixed income would no longer be able to make ends meet.

"I moved to North Carolina to retire. I had my budget worked out, I felt like I was in control. Everyday I get notified of another increase. When does this stop?"

Mary Hartman stated, frustrated with not knowing if staying in North Carolina was going to be realistic.

Coastal communities would be the hardest hit with a 99% requested increase. In December, insurance for both property and vehicles increased for many in North Carolina residents by an average of 9.8%





20,000 used electric cars will be hitting the market as Hertz rental car company has decided to replace those vehicles with gas powered vehicles for their rental fleet. One of the reasons given was the enormous expense of repairs when electric vehicles are damaged in an accident.

Across the country, 12 Attorney Generals have asked the FDA to reduce Marijuana from a Schedule 1 narcotic (which includes heroin and LSD) to a Schedule III narcotic, basically reducing the penalty and restrictions that currently make the organic product a felony in some states. Currently Marijuana is legal as a recreational drug in 24 states and for medical use in 38 states. The Eastern Band of Cherokee Indians voted in 2023 to legalize marijuana sale and possession for adults 21 and older on the tribal lands. The Eastern Band had already authorized its use for medical purposes. This action is the first time a southern state has legalized marijuana use for adults. In states where marijuana has been legalized for recreational use, the criminal market has been undercut and the sales tax has generated millions in tax dollars.

The Governor of Texas has made a bold statement. Governor Abbott signed a bill that would make illegal immigration a state crime. Police would now be allowed to arrest people that entered the country illegally.

"Operation Lone Star" which is a multiagency alliance between the Governor, the Texas Department of Public Safety and Texas National Guard was created to stop illegal immigration and the smuggling of drugs and weapons into the United States. Since the start of the project, there have been almost 500,000 illegal immigrant apprehensions and 40,000 criminal arrests. Over 450 million doses of fentanyl have been seized.

As if living in North Carolina was expensive enough, the N.C. Rate Bureau has submitted a request with the NC Department of Insurance to raise homeowner's insurance rates up to 99%. That doesn't sound legal to me. The Rate Bureau says the average increase would be around 42% across the state, but the coastal region would be much higher in the 79%-99% category. I don't know about you, but there are very few expenses in my life that I can adjust for an increase of 99% without it financially hurting. Apparently, the N.C. Rate Bureau is not made up of homeowners with limited resources for income. What the state must take into consideration is how many people will be forced to drop their insurance all together.

Remember knowledge is power and living is expensive and securing our borders is essential to all of us.



Exploring Some Of The Many Types Of Dance For Health Benefit

I'll start out with the 3 types I am most familiar with, and involved in. Traditional Appalachian Clogging/ Folk Dancing. Clogging is a truly American dance form that began in the Appalachian Mountains and now enjoys widespread popularity throughout the United States and around the world. As the Appalachians were settled in the mid 1700's by the Irish, Scottish, English and Dutch-Germans, the folk dances of each area met and began to combine in an impromptu foot-tapping style, and the beginning of clog dancing as we know it today. Several types of Clogging are Buck, Free style/ Hoe Down, and Flatfoot, which are usually done solo to live Fiddle and Bluegrass Bands, Smooth and Running -Set and traditional Appalachian clogging are usually done in formations changing partners, also with live bands or with CD, vinyl records, with the "Caller" out on the floor with the group calling the different formations. There are Team Clogging, Couples and Solo dancing. Square Dancing is usually 4 to six couples doing formations, changing partners and the "Caller" can be on the floor with them or on the side line calling out the formations to the group on the floor. and the music can be with a live band or vinyl record, tape or CD music. Maggie Valley is the Clogging Capital of the eastern US.

If you have ever had the chance to visit "The Stomping Grounds Barn", in Maggie Valley, you have experienced the best of the best Clogging entertainment! And, Clogging is the State Dance of West Virginia, Kentucky, and North Carolina! Some of the health benefits are: Cardiovascular exercise, strength and endurance, stress relieve, social interaction, and balance and coordination

I've mentioned 2 of the 3 that I am most familiar with, the 3rd being Belly Dancing. Oriental dance or "Raqs-Sharqi" is the correct name for Belly Dance, (also called Middle Eastern Dance), and is one of the oldest forms of dance. The Historical data on Belly Dance is fragmentary as there is relatively little documentation throughout the age of literacy. The name of "Belly Dance" was coined in 1893 by Sol Bloom, an American Event Promoter, who was trying to stir up public interest in the "Streets of Cairo" exhibit at the Chicago World's Fair, (Little Egypt & the Dance of the Seven Veils). This beautiful dance did NOT originate as a dance of seduction for the sultans, but as a folk Dance that people, male and female, would do at joyous occasions. In certain cultures, it was also a dance that "trained women's muscles" for childbirth and was usually performed by women for other women, their families or their husbands, but never for strangers. There are several styles of Belly Dance, to name a few,

American Cabaret, Turkish Cabaret, American Tribal, and Tribal Fusion. Belly Dance is a low impact, weight berring exercise which is especially good for women and it can reduce the risk of

osteoporosis, and is suitable for all ages and body types, good cardio, stress relief, improved flexibility and self-confidence.



Pender County Commissioner Candidate Questions

What is the primary issue facing the county that led you to run for office?

As great a community as Pender County has always been, unfortunately it is overwhelmed with numerous issues that have not been addressed for far too long. 

What is the primary issue facing the county that led you to run for office? As a lifelong resident of Pender County and having spent over 10 years on the Pender County Board of

Education it allowed me the opportunity to witness the effects of rapid unplanned growth. The current UDO hasn't been updated since 2010, the comprehensive land use plan is outdated, and the future land use map doesn't reflect the current needs of the county. With the rapid development Pender is stressed in keeping up the services that the citizens desire and are entitled to. Funds are constantly having to be prioritized to maintain the current level of services leaving little to go towards enhance or expand, this causes areas of the county to become neglected and continue to fall farther behind. While residential development is a way to expand the tax base and has been the theory for a while, there comes a time when the balance shifts to becoming a tax burden Pender is at that tipping point. It is time for more focus directed toward economic growth

If we're being honest, filling the meter takes some of the fun out of arriving at the beach. Beautiful beaches are one of the best things about Pender County, and sometimes it is more important to protect something special rather than make a few extra bucks. 

If elected, what would you do to address the major concerns of the safety of travelers on Highway 17 in the Hampstead area?

Living on the northern side of Hampstead and traveling to work in New Hanover County I realize like anyone the challenges I've had the same pleasure as others, the opportunity to be stuck for extended periods of time getting home. Unfortunately, the option for any local elected official is extremely limited. The county has no control over any roadways, speed limits are set by the NCDOT, law enforcement is performed by NC Highway Patrol, with limited traffic enforcement by the Pender County Sheriff's department. That restricts the local county government to lobbying for those changes, and lobbying for increased law enforcement presents.

Would you consider a moratorium on construction until the bypass was completed?

I have explored the requirements already, unfortunately it isn't as easy as it sounds. NC General statute 160D-107 outlines the requirements.

Pender County Board of Education Candidate Questions

What is the primary issue facing the school systems that led you to run for office?

Building a new K-8 school in Hampstead will be the board's biggest challenge for the next 5-10 years. For example, the Surf City K-8 school opened in August 2018 and it's already over capacity. We cannot make that same mistake again.

As a member of the school board, I've already presented a detailed analysis to my colleagues and the superintendent regarding how the demographic data we're relying on are flawed. We cannot afford to ask the voters to approve more bonds in a few years – and ask the county commissioners to raise taxes – because we didn't do the important work of asking the right questions.

What are your skills and experiences that make you the right choice for Pender County voters?

My experience as a town manager and certified public accountant makes me uniquely qualified to participate in the budget formulation and approval processes. I am an expert in governmental accounting and can ensure financial resources are being used in the most efficient and effective way possible.

As an example of my finance experience at work, in my first six months on the board I identified approximately \$750,000 in wasteful annual spending. When I brought this to the attention of my colleagues on the board, they voted unanimously to cut that spending. We can now use those funds (totaling ~\$3 million over a four-year term) to hire teachers, counselors, bus drivers, and provide employees much-needed pay increases.

I'm also a retired Marine, and I understand the challenges our community's military families face. More importantly, I understand the significant resources the military brings to the table.

As another example of my experience at work, soon after joining the school board I met with representatives from Camp Lejeune to see how the school system could partner with the military to help our students.

As a result of this meeting – along with staff, and fellow board member and retired soldier Brent Springer – Pender County Schools is about to implement an exciting new tutoring program. This program will provide free online tutoring in math and reading to all students in our Topsail area schools.

Further, because the military is providing this program at little-to-no cost to the county, the school system will have enough funding to offer similar inperson tutoring services to all students in our Pender and Heidi Trask area schools.

These are just a couple examples of how my outside-the-box thinking – and desire to be smart about spending – has benefitted the entire county.

Recently a young child was found unattended on Hwy 17 during school hours and was returned to the school by a passerby. If elected, what will you do to ensure something like this never happens again?

Foremost, I'm glad no harm came of this incident and I thank God for the good Samaritan that brought this child back to safety.

After hearing about this incident, I contacted the superintendent the same day to ask that he quickly investigate this issue and come to the board with recommendations for how we can ensure it doesn't happen again. I also asked the superintendent to be fully transparent about his investigation and findings. "Hiding the ball" or issuing politicallycorrect public statements only erodes community trust in the school system.

One of the many lessons I learned in my military career is that accountability is paramount when dealing with situations like this. And, my favorite Marine Corps leadership principle is, "Take accountability for your actions, and seek accountability from others."

The school system clearly failed in this case. We must admit our failure and learn from it. In my opinion (and experience), we learn much more from our failures than we do our successes. But, the first part of this learning process is admitting failure.

I look forward to receiving a detailed investigative report on this incident, sharing that report with the community, and collaborating with teachers and law enforcement professionals to revise our security policies accordingly.

Do you have children or grandchildren that attend the Pender County Schools, and if so, what do you feel are the major issues that affect them?

My son will attend the new K-8 school the community is building in Hampstead, and will be a Pender County Schools student for the next decade. I have a strong interest in the school system's success.

The biggest challenge my son will face – along with all other students in our community – is overcrowded schools. Specifically, every school in the Topsail area is over-capacity and half the schools in the Pender and Heidi Trask areas will be over capacity by 2026.

The school board needs to sharply focus on solving this problem. Smartly allocating the \$178 million in school bonds passed by the voters in 2022 is key – and we must prioritize projects that create new classroom space for students.



If elected, how do you plan on filling the need for more teachers and school bus drivers? Would you support incentives, like benefits and bonuses?

The school system is understaffed, but it's important to realize this is a product of funding. The state only allocates minimal funding, and the county commissioners have been very meager in their local allocations. As a result, it's incumbent upon the school board to find savings where we can to hire more staff and increase pay.

As mentioned, last year I discovered and convinced my colleagues on the board to unanimously support eliminating approximately \$750,000 in wasteful annual spending (totaling ~\$3 million over a four-year term). I support using this funding to fill the need for more teachers and school bus drivers.

Lastly, yes, I firmly support incentives like bonuses for employees who earn them through exemplary service. As another example, in August of 2023 I made a motion to approve \$1,000 retention bonuses for all full-time school system employees. I also made a motion to approve \$5,000 recruitment bonuses for teachers in hard-to-fill positions. My colleagues on the board unanimously approved both of these initiatives.

What is the primary issue facing the school systems that led you to run for office?

The primary issues that led me to run for office are the overcrowding of the schools and improvements needed to make sure our teachers and staff have the tools and support they need to adequately support the learning of our children. Having lived in the Pender/New Hanover County area for most of my life, I have witnessed first-hand the growth of our community. This growth has increased our student population to the point that many of our schools are left with inadequate learning areas and not enough teaching staff. There is a current plan for a new K-8 school which will help to alleviate some of the overcrowding. However, along with the construction of the new school, we will need to make sure that our salaries for teachers and staff are structured in a way that we will not only be able to keep the staff we currently have but attract the additional staff needed. Having multiple family members who have and are working in school systems across the country, I have first-hand knowledge of the monies our teachers are outlaying to ensure their classrooms have adequate supplies. I do not believe that any teacher, staff

member or parent should be requested to supply items necessary for the classroom. If elected, I will work with my fellow Board Members to look for areas within our budget that will allow us to ensure these supplies are provided without asking teachers, staff members or parents to provide them.

What are your skills and experiences that make you the right choice for Pender County voters?

As an owner of two different successful businesses since I was 28 years old, I acquired many skills such as data analysis, budgeting, employee relations, forecasting, and customer service. I relate well to people and am open to listening to all points of view. I know that the decisions I will make will not please all, but I am running for this seat to look out for the best interest of the education system and have no other hidden agendas in place. I pride myself on my people skills and will work to try to bring unity between the Board and County Commissioners so that we can work to the common goal of improving our school system so that we can empower our children to achieve their dreams.

Recently a young child was found unattended on Hwy 17 during school hours and was returned to the school by a passerby. If elected, what will you do to ensure

something like this never happens again?

I am confident that the principal, vice principal and staff at the school have reviewed the circumstances around the incident and have put additional safety measures in place to ensure that this does not happen in the future. Additionally, while we hope these types of incidents will never happen, I am sure that other schools will take this experience and re-evaluate their campuses to aid in the prevention of this type of incident in the future.

Do you have children or grandchildren that attend the Pender County Schools, and if so, what do you feel are the major issues that affect them?

I do not have any children or grandchildren in the Pender County Schools. However, as a community business owner and resident, I encounter parents, school staff and students weekly. Based on the information I have heard, I feel like the number one issue affecting our students and teachers is the overcrowding in the classrooms. The large classroom size does not allow for an environment in which teachers can adequately work with our students and is not conducive to learning. The second issue is the focus on standardized testing. While I recognize that standardized testing is mandated at the state level, it

is not necessarily the best way to evaluate the full range of skills and knowledge that students have or the effectiveness of our teachers. They create a culture of teaching to the test, which limits the creativity and flexibility of both teachers and students. Not all students learn the same and we need to provide flexibility in education methods to help those students who need a different way of learning succeed.

If elected, how do you plan on filling the need for more teachers and school bus drivers? Would you support incentives, like benefits and bonuses?

I feel that our salary and benefits packages must be competitive with at a minimum our neighboring counties. I would support review of increasing the supplements the county funds over onetime bonus or incentive payments as that shows long term commitment and value. I would support the review of our benefits package to see how it can be improved and extended to those who may not currently be allowed to participate. While salary and benefits carry a lot of weight in hiring and keeping employees, we must also look for ways to make sure that staff feel valued and appreciated.

Onslow County Commissioner Candidate Questions

What is the primary issue facing the county that led you to run for office?

I see a real need for the Onslow County Board of Commissioners to be more "in touch" with & to listen to the PEOPLE of Onslow County, particularly on the south end (Stump Sound: Sneads Ferry, Folkstone, Holly Ridge, North Topsail Beach & Surf City) part of our county. I propose periodic town hall meetings in all areas of the county, where citizens can bring their needs & their recommendations to me, so I can properly represent them to the entire Board of Commissioners. No one in a public office should ever make any decisions solely based on campaign contributions. Decisions should always be made for the legitimate needs of the people, in general.

If elected, would you support an increase in local option sales tax, and if so, would you support a decrease in the property tax rate?

Yes to both. It is well known that I have been speaking with members of our county's State delegation (Senate & House of Representatives) about this issue for a long time. I recommended a local quarter cent sales tax increase, which would bring a significant increase to our county budget for county needs. Then, after evaluation. the county property tax rate can be reduced for property owners. We have many people shopping & visiting our county, who make purchases of items & services. The quarter cent tax increase would be barely noticed by purchasers. I think it is unfair to place most of the county tax burden on property owners. If any State senator or representative is not in favor of raising sales tax for this minimal amount, they should put it to the PEOPLE as a referendum & let the PEOPLE decide the next election. What are your skills and experience that make you the right choice for **Onslow County voters?**

As my public service record shows, I have years of experience in policy making, budgeting, managing, administering & LEADING in the military service & in Onslow County. I had to defend a security system maintenance budget to the U.S. Navy Comptroller in Washington, DC when I was on active duty. As the Police Chief of Albert J. Ellis airport, I proposed a budget to the airport director for my police force. As Sheriff of Onslow County for two terms (8 years), I was responsible for all budgeting for the Onslow County Sheriff's Office & the Onslow County Detention Center (Jail). A very detailed & complex process. My goal was to only ask for needed funds & not to "over spend" taxpayer money. During my second term, I voluntarily attended almost all Board of County Commissioners (BOC) meetings, for security & to reduce Deputy Sheriff overtime. I am very well aware of the procedures that the BOC follows. I have always been honest, transparent & accessible to the PEOPLE that I serve.

If elected, would you support the construction of a multi-purpose sports and entertainment complex in Onslow County?

Yes. I would support a public/private partnership to find a location, determine the appropriate size, layout & construction & ensure that, in the long run (years ahead) the county citizens will benefit by bringing more visitors & events (sports, military events, conventions, etc.) into our county. The associated benefits would be more tourism funds, sales taxes, employment opportunities for our county citizens, especially our young people. Of course, the cost will be evaluated (cost/benefit analysis).

If elected, would you attend local town meetings that are within Onslow County to hear their concerns and to show the support of the Onslow County Board of Commissioners?

Of course. As the public record shows, as Sheriff of Onslow county, I organized multiple town hall meetings in all parts of Onslow County, to inform & to listen to the PEOPLE. These town hall meetings were conducted in a frequent basis, until a hurricane & a viral pandemic put a stop to it. I do understand that, as just one member of the Board of Commissioners, I would not be able to organize a town hall meeting just by myself. However, if the citizens of a city, a town or an unincorporated community of Onslow County want to organize a town hall meeting, I will make efforts to attend. (I might wear blue jeans & take notes for action).

P.S.: One of my goals is to reduce EMS response times to the southern area of our county. I also strongly believe in school & church security & plan to work closely with the OCSO to keep our citizens, old & young, safe.

Coastal Common Sense

What seems to be perpetual chaos and terminal inactivity in the United States Congress could easily be remedied. By turning the attention of both houses of Congress back to we the people instead of the the government, many of our political, economic and social problems could be resolved. The cure for congressional paralysis is term limits for all members of Congress.

The Founders of our great country wisely created a government to represent the people with a system of checks and balances. Each of the three branches of government, the Executive, the Legislative and the Judicial, were designed to limit the power of the other branches so that no single branch could replicate the tyranny of the King of England.

The ingenious system of separation of powers that the Founders devised most importantly secured the liberties and freedoms to the people that were guaranteed in the Bill of Rights. Having studied all the great civilizations in human history, the Founders knew that only a government based on decentralized power could protect those God-given rights. Thus, in 1789 the U.S. Constitution was written to outline how the checks and balances under separation of powers would shield the people from a tyrannical government.

That system has worked well for 247 years, but the Founders knew that we are not governed by angels and human nature would eventually gravitate towards a power structure that would limit the freedoms of the people and expand the control of the state. That's where we are today.

So, the Founders in their infinite wisdom included an escape clause in the Constitution that allowed that historic document to be amended. Article Five of the Constitution outlines two ways that amendments to the Constitution can be made. The first is through a vote of Congress, and the second is through a vote of the state legislatures referred to as a Convention of States. Since Congress would never vote to limit their own power, door number 2 is our only choice.

Members of the House of Representatives are now elected for 2 year terms and members of the Senate for 6 year terms. These short windows demand that our elected representatives spend most of their time on their reelection campaigns rather than on passing laws in the best interests of the country. They become pre-occupied with making decisions based on retaining their own personal power positions at the expense of the greater good.

An amendment to the Constitution for term limits for all members of Congress under Article Five would eliminate their focus on themselves and their reelection, and return their energies to what's best for the country. Knowing that the burden of re-election was off their shoulders and they are only there for a limited time, members of Congress could then vote for solutions to the country's problems without regard to their own political futures.

Here's how it works under Article Five: 34 state legislatures submit applications and delegates for a Convention of States to vote on the single issue of term limits for all members of Congress. The delegates draft language for a proposed term limits amendment. Each state gets one vote. When 38 state legislatures ratify the term limits amendment it then becomes part of the Constitution - as has been done 27 times before with other amendments. Right now 19 states have approved such an amendment.

The Term Limits Amendment would designate the length of terms for each

house of Congress. E.g., the House of Representatives could be limited to two terms of four years each and the Senate could be limited to two terms of six years each. That way, our representatives are only in power for a short amount of time instead of 47 stagnant years like Joe Biden.

Onslow County Board of Education Candidate Questions

Melissa Oakley



What is the primary issue facing the school system that led you to run for office?

My thoughts on the primary issue have changed somewhat since the 2020 election cycle when I ran the first time. Today, I believe, as then, that we have more than one critical issue at hand. In 2020, I believed a primary issue was maintaining and updating facilities as many needed repairs to roofing from lingering damage from the blows of Hurricane Florence, increasing bus driver pay to hire more drivers, and increasing the supplemental income incentive for teachers to be more competitive in the workforce to bring in new teachers and staff to fulfill vacancies. Today, the most pressing issue is rapid growth and school capacity concerns. For example, Coastal Elementary School was just opened in 2022 and has already reached capacity. Dixon High School is now the home of the largest student population in the county. Because of this, the district has applied for a grant that would allow for the complete renovation and expansion of Dixon High School at no match to local taxpayers funding. The Stump Sound area growth is at such a rapid pace we are likely to need an additional elementary school in the next five years or less. We recently broke ground on another elementary school in the Swansboro/Belgrade area where the old elementary school used to be out in the Deppe Rd area due to growth in population in that area. Additionally, we are still facing staffing shortages, just as in 2020, and most of all, increasing school safety initiatives. We have filled some vacancies and have new support

positions filled while others are still available. We also have an increase in behavioral and mental health concerns that led to increasing mental health services through the school's providing referrals for families to utilize at low or no cost depending on insurance coverage through Trillium Healthcare. Growth creates overpopulated schools that pose additional safety risks, so I think by addressing the growth problem, we can better address the safety concerns. It is easier to manage less crowded environments than overcrowded environments and mitigate risks.

What skills and experiences make you the right choice for Onslow County voters?

I'm an NC Native, born and raised in the foothill's region of our beautiful state, where I attended public schools, so I hold the values of most native North Carolinians. I hold a dual associate degree in Business Administration and Criminal Justice. I am enrolled at the University of Mount Olive in a Bachelor's program for Judicial Studies. I have a diverse background of work experience from skills programs that led me to pursue certification as a nurse's assistant, medical office management, and a childhood education worker. Additionally, I have a background in preschool, as a pharmacy technician, in hospitality, tourism, domestic services, recruiting, management, staffing, and restaurant service. My most important role has been as the mother of three children who have all been blessed by the opportunity of education through Onslow County Schools since our family moved here as a part of military service when my husband was on active duty. Beyond these things, I have served as a mentor through military programs for spouses, such as LINKS, and as an FRA: Family Readiness Assistant. Locally, I served as a Guardian ad Litem for five years, advocating for abused and neglected children in our judicial system. However, I have been inactive for some time due to the conflict it poses with my role as an elected official in our county. I have supported and advocated for the United Way CHEW program, serving supplemental nourishment for children across our county, with over 900 children served weekly. I am connected with the many demographics of our wonderful community and understand the impact many of our families face economically, socially, physically, or otherwise.

School safety has been a hot topic at Onslow County School board meetings. If elected, what will you do to help ensure the safety of students and staff on school grounds?

I will keep tilling the ground. Since I was elected to the board of education in 2020, I have avidly supported advancing security measures and initiatives that would improve our facilities structures as many of our schools are over 30 years old. Some of the facilities were built when society had not remotely imagined the safety issues we face today in society or a school system. Vaping has become an enormous problem and concern with the rise in the fentanyl crisis, and one of my greatest fears has been that a student may obtain a vape that is laced with a substance that could cause adverse health consequences or even a fatality. Because of this and other concerns with our current opioid and fentanyl crisis, I advocated for the placement of Narcan in our school's district-wide. The Narcan boxes are nasal inhalants, and they were provided through a federal grant, SAMSHA where members of our community wrote the grant to provide full funding for the Narcan, training for staff to administer and this requires no match of local tax dollars. Additionally, I have advocated fervently for vape detectors and requested that funding from the state legislature. Though the funding request was not approved in the annual state budget, the district has applied for a NC Center for Safer School's grant that will provide the necessary funding for them if we are granted the funding. Not only will these HALO vape detectors provide the level of assurance that will detect the use of vapes, they also provide an additional layer of security that detects key words like "fight, knife, gun" and other sound effects that would exhibit a potential threat or danger. After the tragedy at Northside High School in September of 2022 where one student lost his life, I proposed the use of mobile metal detectors at the schools with a focus on sporting events and other special events. This was because the data trends reflected the impact of violent incidents and threats at athletic events in certain areas of the county. Because of that, we also increased law enforcement presence at the schools greatest affected by threats of violence. Since then, we've increased the number of SROs and at least 3 of our high schools have two SROs, and one in every school otherwise. Our budget has permitted two on staff law enforcement officers who are housed at the central office, one from JPD and one from OCSO. We also funded a K-9 Officer Gus who is trained to detect explosives. Over the last few years. I've advocated for stronger legislation to our state senator and house representatives regarding the Delta 8 & 9 gummies after adverse health effects occurred at one of

our middle schools last year where

students were sharing what was believed to be "snacks". These should never make it into the hands of youth or into our schools transported by youth. We approved school monitors in our fiscal budget for this year for our more at risk high schools to add additional supervision. Many of these jobs are held by parents, retired teachers, and the veteran population. I have also advocated for silent alarm systems that would allow teachers and staff to immediately lockdown with a radar type system guiding law enforcement to the directly impacted area(s) in response to any possible event of mass violence. have advocated for Centegix silent alert systems that are badges that teachers and staff can use in conjunction with the aforementioned school radar system that will work effectively without WiFi or cellular. Funding constraints are an issue for swift implementation of additional layers of this magnitude. In December 2023, I began drafting a policy revision proposal to the existing School Safety policy that would bolster the communication between administrators, staff, and the SROs in reporting incidents of misconduct or violence to ensure a partnership between the two in combination with alleviating any strain on administrators to solely determine whether or not an act warrants a juvenile referral, purely administrative disciplinary action or a combination. This adds another layer of responsibility and accountability as well as balance between the school and law enforcement agencies. We recently unanimously approved the launch of Evolv weapons detection systems which I was one of three board members to recommend.

Do you have children or grandchildren that attend the Onslow County Schools, and if so, what do you feel are the major issues that affect them?

My two youngest children are students at Dixon schools and I cannot think of any major issues that have greatly affected them. We have fortunately had great teachers who have helped mold our children as individuals and recognize that each student is different from the next.

If elected, how do you plan on filling the need for more teachers and school bus drivers? Would you support incentives, like benefits and bonuses?

I have been consistently working for improvements in this area. When I was elected in 2020, I ran on increasing bus drivers' pay and we did raise the pay to \$15 an hour to which now is \$16 an hour starting pay with \$2500 sign on bonuses. Retention bonuses have been provided for the past few years with at least

\$1000 for those qualifying staff who have stayed onboard for the entire fiscal year. I voted proudly in support of these bonuses and pay increases. Additionally, I ran on increasing teachers' supplemental income in 2020 to which we voted unanimously on a 2% increase from 10% to 12% which is quite competitive for our region and statewide for counties our size. Teacher assistants oftentimes are assigned to a classroom

to substitute but were not given the substitute pay rate which would have been a higher rate and now they are paid for that rate and were offered backpay for the last fiscal year which this change came into effect. Through working cohesively with staff, and applying the relevant general statute, I was able to successfully advocate for this change on behalf of the teacher assistants. I believe one of the key issues with obtaining and retaining bus drivers is the lack of respect for adults in the public school system from some students and parents.





Next steps with the Evolv visitor scanning system will be important. It will be vital to continually review the safety related series of policies, including student behavior policies, and implementation practice. A board member's responsibility would include ensuring financial allocation for resources, training staff and students in emergency preparedness, conflict resolution, and mental health awareness. A robust working relationship with law enforcement is vital as well as keeping abreast of vetted safety trends and hearing concerns from the community.

Students want and deserve challenging courses, including workforce skills/credentialling, career choice internships and other student enriching opportunities. 

What is the primary issue facing the school system that led you to run for office?

The decision to run started to form while attending a safety town hall meeting. In my role as a Jacksonville Police Officer, I attended this meeting along with some parents and students from the school district, a number of citizens not connected to any specific schools, and a few elected officials. The stated purpose was a good one, to discuss ideas to improve school safety. The result was light on ideas for improvement, but even if the vast majority of our families and teachers feel safe, we can always make improvements. This involves engaging with local law enforcement agencies, seeking input from areas that have successfully address similar issues, and welcoming ideas from parents, teachers, and stakeholders. I respectfully refrain from discussing current leadership details, as I may not have the complete information on how matters are currently being handled.

I bring a wealth of experience in education, a strong professional background, and a steadfast commitment to my faith. If elected, how do you plan on filling the need for more teachers and school bus drivers? Would you support incentives, like benefits and bonuses?

From the time I graduated at Swansboro High School, throughout my law enforcement career, and as an involved parent in multiple schools, I've been a direct witness to over 3 decades of safety improvements with the Onslow County Schools. A lot of recent attention has been given to physical safety measures and there will always be new options to consider given changing times. Knowing that there is no perfect physical safety measure, while the district continues to update and upgrade those physical features, some of the ideas I'd like the district to consider are: establishing a site for intensive behavioral needs particularly for the early grades, expanding partnerships with organizations like MENAC Inc. ("a Christian Veteran founded and operated mentoring organization"), with the successes but limited size of OCLC. investigating what other alternative school options and site locations are needed to assist principals in working with students with different needs, continuing to work with law enforcement and emergency service partners, expanding options like a twilight (night school) program, adding a JROTC program, exploring a middle college option and/or a full high school option at the Skills Center, adding EMT, Emergency Management, and Public Safety to the existing Fire Fighter program in order to create a Public Safety Academy, and working with our schools to identify and

If elected, how do you plan on filling the need for more teachers and school bus drivers? Would you support incentives, like benefits and bonuses?



There have been multiple complaints from parents of different types of abuse at school that have gone unresolved or ignored. Students have a right to attend school and feel safe. They also need to know that they will be heard. It's emotionally damaging to a child to deny their trauma when you are responsible for their safety. It isn't necessarily a matter of policy, but strict adherence to the current policy.

The schools have implemented safety measures such as clear backpacks and metal detectors which are good steps forward, but there are deeper, more cultural issues that need to be addressed. The first thing that can be done to fix this issue is to stop treating parents and teachers and the community as opposing entities. Our teachers are there because they care about kids and want to see the next generation succeed. And naturally, parents want to be sure their children are safe and getting a quality education for them to succeed. At the end of the day, we have the same goals in mind, so we should all be able to come together and find real solutions.

I would be in full support of increased pay and benefits for bus drivers and teachers. The current national average hourly wage for bus drivers is ~\$21.36 but Onslow County pays somewhere around \$15.00. This has caused real problems for students throughout Onslow County. We are growing, and we must keep up with that growth.
