On March 12th, US District Judge Saylor will decide what to do about the \$10 Billion (with a B) lawsuit against firearm manufacturers in the USA brought on by Mexico. The lawsuit, filed in 2021, states that over 500,000 firearms were illegally brought into Mexico through the United States and therefore the big firearm manufacturers are responsible for supporting the Cartels and the violent crimes that accompany them. In most cases, the Protection of Lawful Commerce in Arms Act (PLCAA) would be used to dismiss the lawsuit, but in this case, Mexico is claiming the gun manufacturers committed criminal acts. The firearm manufacturers include Glock, Beretta USA, Smith & Wesson, Colt, Sturm, Ruger & Co. and Barrett. You know what would help to reduce the illegal trade of firearms into Mexico? A secure border.

On a different note, the Mexican cartel is setting up shop on Indian Reservations across Montana. The State, known for its expansive open spaces, only has 20 DEA agents. Deaths by Fentanyl have sky rocked and now the Indian Reservations are in a State of Emergency.

You know what would help reduce the illegal cartel drug trade in Montana? A secure border.

Georgia Senate Bill 344 is proposing a tax-free holiday for firearms,

ammunition, and firearm accessories. The holiday would be five days in October and designed to promote hunting.

A gun shop and the former gun shop owner of Federal Way Discount Guns in Washington State has agreed to pay a \$3,000,000 (million) dollar fine for selling magazines that hold more than 10 rounds after the law was changed in 2022. Another shop was also fined but that amount was only \$15,000.00 for violating the law. The gun shop owner's defense was that local law enforcement told him the law was unconstitutional and therefore he didn't need to worry about it.

In 2020, the 9th Circuit Court of Appeals ruled that a ban on "large capacity" magazines was unconstitutional and violated a citizen's 2nd amendment. To date, 14 states still have restrictions and I bet you can guess which ones those are.

57% of Ohio voters decided to vote for marijuana legalization, but an Ohio representative is warning her colleagues that their movement to create restrictions was against the will of the people. "People have told us time and time again when Issue 2 was passed what they want. All we're doing right now is going against the people's will." A smart politician!

Gangs of young men from Venezuela are impacting the safety of tourists and residents in New York City. A 15-year-old male, who arrived a few months ago from Venezuela, was arrested for shooting a woman in the leg in Times Square, surrounded by cameras.

Just when you think the world can't get any stranger, PETA (People for the ethical treatment of animals) may have gone a bit too far. With a world full of living animals that need help and protection, PETA has decided to take on the manufacturer of fake animals. Carousel animals, like horses, camels and elephants, suddenly need protection from abuse. The president of PETA wrote, "Animal-themed carousel sets reinforce the notion that these sentient beings are simply here for our entertainment, rather than individuals with the same capacity to experience fear, pain, joy and love as any of us."

Does this person not realize carousel animals were made exactly for our

Field Day is a picnic, a camp-out, practice for emergencies, an informal contest and, most of all, fun. It is a time where many aspects of amateur radio come together to highlight the many roles. While some will treat it as a contest, other groups use the opportunity to practice their emergency response capabilities. It is an excellent opportunity to demonstrate amateur radio to the organizations that amateur radio might

Why Bees Are Essential To People And Planet

The greatest pollinators

Bees are part of the biodiversity on which we all depend for our survival. They provide high-quality food—

honey, royal jelly and pollen — and other products such as beeswax, propolis and honey bee venom.

As the landmark 2019 report from the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES) notes, "Sacred passages about bees in all the worlds' major religions highlight their significance to human societies over millennia."

Beekeeping also provides an important source of income for many rural livelihoods. According to IPBES, the western honey bee is the most widespread managed pollinator globally, and more than 80 million hives produce an estimated 1.6 million tonnes of honey annually.

And pollinators contribute directly to food security. According to bee experts at the Food and Agriculture Organization (FAO) of the United Nations, a third of the world's food production depends on bees

When animals and insects pick up the pollen of flowers and spread it, they allow plants, including many food crops, to reproduce. Birds. rodents. monkeys and even people pollinate, but the most common pollinators are insects, and among them, bees.

Bees at risk from pesticides, air pollution

But sadly, bees and other pollinators, such as butterflies, bats and hummingbirds, are increasingly under threat from human activities.

Bee populations have been declining globally over recent decades due to habitat loss, intensive farming practices, changes in weather patterns and the excessive use of agrochemicals such as pesticides. This in turn poses a threat to a variety of plants critical to human wellbeing and livelihoods.

Air pollution is also thought to be affecting bees. Preliminary research shows that air pollutants interact with scent molecules released by plants which bees need to locate food. The mixed signals interfere with the bees' ability to forage efficiently, making them slower and less effective at pollination.

While the vast majority of pollinator species are wild, including more than 20,000 species of bees, the mass breeding and large-scale transport of pollinators can pose risks for the Topsail Times is printed by the Topsail Times Ne aper, LLC. transmission of pathogens and parasites. According to the IPBES report, better regulation of their trade can decrease the risk of unintended harm.

Taking urgent action

But there are positive signs. In May 2018, the European Union upheld a partial ban on three insecticides known as neonicotinoids to mitigate the lethal threat they pose to bees and their trickle-down effect on pollination as a whole.

Representatives from 188 governments gathered in Montreal, December 2022, for the United Nations Biodiversity Conference (COP15) which resulted in the adoption of the Kunming-Montreal Global Biodiversity Framework (GBF)

The GBF aims to address biodiversity loss, restore ecosystems and protect indigenous rights. The plan includes concrete measures to halt and reverse nature loss, including putting 30 per cent of the planet and 30 per cent of degraded ecosystems under protection by 2030.

"Increasing crop and regional farm diversity as well as targeted habitat conservation, management or restoration, is one way of combating climate change and promoting biodiversity," says UN Environment Programme (UNEP) biodiversity specialist Marieta Sakalian. "Governments need to take the lead."

It is precisely to encourage governments, organizations, civil society and concerned citizens to protect pollinators and their habitats that the

Empowered People Keep Both Feet Planted Firmly On The Ground

Several years ago, as I was returning home from a speaking engagement, I decided to stop in a town about two hours from home to stretch my legs. At that time the best place in the world for me to stretch my legs was Stein Mart Department store, so that is where I chose to stop. It was late on Sunday afternoon so there were few customers in the store. As I moseved around, I noticed to my left a display of scarves, and one on the second row caught my eve. I thought it might match the colors of the pants that I was wearing. I stopped and lifted my knee to the scarf to see if I was right.

Before I go on, I want you to picture the scarf display. The scarves were hung on plastic rings and the rings were placed on metal arms that stuck out from the display. The metal arms were curled up at their ends so the plastic rings wouldn't fall off. I lifted my knee in the air, draped the scarf over it and found much to my sadness that the two would not go together. As I lowered my leg, my pant leg caught on one of the metal arms of the display. I lifted my knee to dislodge the pant leg but to no avail. I lifted it once again, but it was still caught and would not detach.

So. there I was, STUCK. I looked around and there was no one in sight to

help me. WHAT AM I GOING TO DO? WHERE IS HELP WHEN YOU NEED IT? DO I YELL OUT FOR HELP? ONLY I COULD MANAGE TO DO THIS!! I was thinking all of this while standing on one leg. I was 60 years old at the time and my balance was not what it used to be. Then I started beating myself up. WHY DID I STOP HERE ANYWAY? HOW CAN ANYONE BE SO DUMB? I SHOULD HAVE NEVER STOPPED GOING TO YOGA. WHY DIDN'T I PAY MORE ATTENTION? When I exhausted my arsenal of negative selftalk, I decided not to embarrass myself by yelling for help, but to simply bend over closer to the rack and pull my pants leg off the metal arm. As I bent over and grabbed the pant leg, I lost my balance and fell on my back in the middle of the store with my feet flying straight up in the air. I am sure that it was a sight to behold.

I was stunned for a minute. I could hear shoppers talking nearby, but still, no one came to my rescue. I pulled myself together, checked all of my bones, and slowly got up and quickly left the store. I was extremely lucky that my feet went up into the air because it dislodged the material from the metal arm of the display. If it had not, I would have pulled the entire rack of scarves on top of me. I was also lucky that I did not get hurt and that no one saw me. I did not have to go through the humiliation that comes with falling in public. I can now laugh at myself over this, but not at the time.

I share this story because I know there are some of you out there who are precariously perched on one proverbial leg in some area of your life, and you feel stuck. I am sure that you have asked yourself the same questions that I asked, and I know you are most probably beating yourself up just like I did. You may be too embarrassed to ask for help or you do not know where to turn for help. I also know that unlike mine, your dilemma has probably been going on for quite some time. And finally, I know that if you do not fess up to someone and allow them to give you help and guidance, you too will lose your balance and fall. When you fall, you may get hurt. You may hurt others. You may suffer the humiliation of public embarrassment. Asking for help may be difficult, but hopefully, it will give you the strength and confidence to do whatever needs to be done appropriately.

Health issues that you are ignoring Weight issues that may be leading to health issues

Some questions to ask yourself that might be helpful:

How long have you known on some level that you are perched on the edge of a major problem or maybe smack in the middle of one?

To whom have you admitted the problem?

Who would be helpful if you admitted the problem?

What has kept you from taking action steps to solve the problem?

If you knew what steps to take to solve the problem, what steps would you take?

If you were not afraid of the consequences, what steps would you take to solve the problem?

What excuses are you making up and telling yourself about this problem?

What is the TRUTH about you and this problem?

What is keeping you from taking action on the problem today?

Coastal Common Sense

The Topsail Beach Town Commissioners think they have dodged a bullet with the withdrawal of the Olsen family development application for The Point parcel of land at the south end of Topsail Beach. However, on the contrary, they may very well have paved the way for a larger more offensive future development.

The Olsen application was an extremely low density request for a zoning change on this 150 acre private land at the very south end of Topsail Island. The applicant was asking for a permit to build a maximum of 8 single family houses on the parcel, over an extended time period. They had agreed to many zoning and environmental conditions, some unreasonable, made by the Town commissioners in order to procure the permit. But in the end, the demands of the Town became too arduous, time consuming and expensive for the applicant to comply with. Thus their recent withdrawal of their development application.

This 150 acre parcel of land is privately owned, but has been mistakenly seen as public land and used freely by locals and visitors for decades creating the false impression that the land was open to the public. As the years of unhindered access to the land passed, people became accustomed to using the pristine parcel without interference and considered it their own.

And for good reason, as this parcel is one of the few remaining large tracts of undeveloped private land on the Carolina coast. The lightly vegetated dunes, home to coyotes and foxes, tower over miles of pristine coastline adjacent to the Topsail Sound Inlet. Waves break slowly along the deserted shore after being knocked down by several hundred yards of sand reefs approaching the dunes. And the sunsets to the West over the Inlet offer incomparable firey beauty every evening.

The wild Atlantic storms and currents through the years have relocated sand from the North end of Topsail Island and deposited that treasure along this sparse beach creating a coastline that continues to grow bigger every year. The parcel has expanded annually with just the wind and the tides as its master. No wonder fishermen and families have used this quiet slice of oceanfront heaven as their own for decades.

No place on the North Carolina coast is any more beautiful.


The approval strategy by the Town was to make the application process difficult and restrictive in order to keep any building on the parcel as low key as possible; and then approve the permit so a low density known commodity would be developed on the site. But much to their surprise, the applicant threw in the towel under the Town's heavy planning and zoning burden. Something about all the well laid plans of mice and men comes to mind.

Now the Town Commissioners have a conundrum. Since they have laid out their numerous, some say unreasonable, conditions for development approval on the site, they have cleared the runway for a future development application from a big, professional development company with full-time legal counsel, inhouse architectural engineers and environmental impact study (EIS) staff that will likely be asking for a much larger, higher density and more offensive permit for the site.

This would be a future applicant that has the resources to outlast any conditions the Town might place in their way. The Commissioners may live to regret not approving the minimal impact permit for 8 houses and be forced to approve some monstrous future 80 house development that would ruin the natural setting of the site and preclude any future use and enjoyment by the public.

The Town still has a choice. They can wait for the big city blues to come calling with an unsightly high density project, or go back to the Olsens and make a deal for their low density family camp. The fate of this heavenly coastal parcel and the future of Topsail Beach rests with this timely decision.

"Customers can experience the same quality food here that they would enjoy at True Blue," Bill stated.



John Rouse Release

On June 27, 2023, a report was filed with the Jacksonville Police Department in reference to a report that John Rouse had sexually abused a child. The case was forwarded to the Onslow County Sheriff's Office, as the incident reportedly occurred in the County.

Through further investigation, it was learned that John Rouse had been accused of sexually abusing a different child in 1996. Law Enforcement met with the Onslow County District Attorney's Office and a warrant for Indecent Liberties with Child was issued for the recent case and the 1996 case.

On February 15, 2024, John Rouse, 68years-old of Leslie Drive in Hubert, was located in Carteret County by the Carteret County Sheriff's Office and released to Onslow County authorities, where he was arrested and charged with (2) Counts Indecent Liberties with Child. Rouse was given a \$40,000 secured bond. His first appearance was set for February 16, 2024.

Assisting agencies were Florida Child Advocacy Center and the Carteret County Sheriff's Office.
