

Southport Mass Shooting Suspect Arrested

Press Release from City of Southport

On Saturday, September 27, 2025 at approximately 9:30 PM, members of the Southport Police Department were dispatched to calls of shots fired with multiple injuries at the American Fish Company, located at 150 Yacht Basin Dr, Southport, NC 28461.

A boat with a single occupant opened fire on American Fish Company, fatally wounding three patrons, and injuring five others. The boat then fled the area, towards the Intracoastal Waterway in the direction of Oak Island.

Shortly after 10:00 PM, the U.S. Coast Guard observed a single individual matching the description of the shooter, loading their boat at the public boat ramp at NE 55th Street in Oak Island. The Coast Guard who detained the suspect and was

then held by the Oak Island Police Department before being turned over to the Southport Police Department, with assistance from the North Carolina State Bureau Investigation.

The suspect, Nigel Max Edge, has been arrested and charged with three counts of first-degree murder, five counts of attempted first-degree murder, and five accounts of assault with a deadly weapon with intent to kill, inflicting serious injury.

Note from the Topsail Times: Edge's dog was also on the boat with him at the time when he allegedly opened fire and has been taken into the custody of the BCSO Animal Protective Services.

Importantly, there is currently no known further credible threat to the

Fun with Facts in simple terms:

Did you know in North Carolina you cannot get an NC Conceal Carry permit (CCP) if you:

- a) have a felony or imprisoned for more than a year
- b) been convicted of domestic violence (assault on a female)
- c) renounced your citizenship
- d) been dishonorably discharged from the military
- e) been adjudicated mentally defective
- f) are a fugitive from justice (my favorite)
- g) addicted to drugs or any controlled substance
- h) are an illegal alien unlawfully in the United States
- i) are subject of a restraining order

Of course the requirements go into more detail, but you get the idea.

I have had people contact me and ask, since they were convicted of armed robbery, can they still get a conceal carry permit. Ummmm no.

The law has recently changed regarding DWI's (or DUI's) where you are prohibited from getting a CCP for three years reduced from 5 years.

Many people think that since Purchase Permits are no longer required in North Carolina that a

Conceal Carry permit has no value. That is not true. We are not a Constitutional Carry State (yet) and until that happens, a person must have a CCP to carry concealed. We are an open carry state, which allows a person 18 years of age or older and legally allowed to own a firearm to carry open, unless otherwise posted. A CCP is also good for purchasing firearms since no additional background check needs to be done.

How do you get a NC Conceal Carry Permit? Not on the internet, that's for sure. North Carolina requires an 8 hour class that includes shooting a firearm and taking an exam. Once you have completed the course and passed the exam, you make an appointment at your local Sheriff's office and they will fingerprint you and send off your information. If your background check is good, you will receive your CCP permit in the mail, usually 4-6 weeks later. Do yourself a favor and get that thing laminated!

In case you couldn't guess, myself, my husband and both of my children are proud holders of North Carolina Conceal Carry permits.

My father, a veteran of World War II, told me something one day that made perfect sense. He said that when a soldier was being sent home,

they were put on a ship, which may have taken weeks to return to the USA. During that time soldiers had time to grieve, get angry, talk to others about what they had been through, and time to decompress. He said PTSD certainly existed back then, but it wasn't the same.


A concern that we discussed, usually after a news report of an act of violence involving a service member, current or former, was that these soldiers were in the heat of battle one day and sent home and could be sitting on a couch watching football a few days later. No time for healthy decompression.

I know people that have made the military their entire lives, and the day they retire things start going south. They don't have the structure anymore. They feel disconnected from the world they know.

I don't know anything about the two men this past week that committed such acts of violence as shooting into a group on a dock at a social gathering or violating the sanctuary of a church and setting it on fire. I don't know what they went through, what help, if any, they had received. I don't know if somehow the system failed them and why the citizens had to pay the price. I wish I had answers.

I wish I had explanations, but I don't. My only fear is that perhaps we are asking too much and not giving back enough.

Remember knowledge is power, we need to work toward restoring compassion, which seemed to disappear after Covid, and getting a Conceal Carry Permit is still a good thing. I would also like to wish my father a happy 101st birthday in Heaven. Your knowledge was the greatest gift, and I miss you every day

Coastal Common Sense



1) What 3 changes, if any, would you like to see in the community you will be representing over the next four years?

I would like to see improvement in how citizens are treated by some of the town council members and town employees. I think some of them have forgotten their duties are to the community and not to themselves. This is a very small town, and we should have small problems and lots of festivities and fun. Somewhere along the line there came a great disconnect, and that needs to end.

As with any profession, training needs to be constant to make sure our town staff is providing the best services possible to the community. Our website is outdated, we do not offer on-line features, such as permits and payments. Access to minutes from previous meetings sometimes takes months. Minutes from planning board meetings and committees need to be available as well. We need to catch up to all our neighboring communities when it comes to transparency through having all meetings live and in real time as well as accessible to viewers at a later time. These meetings need to include regular town meetings, special meetings and planning board meetings.

I would like to bring back the Holly Festival, which was held on the 1st Saturday in November and included a parade that concluded with Santa on a Fire Truck to kick off the holiday season. I would like to add a seafood festival to our town. We are now home to the world-famous Atlantic Seafood and we need to take advantage of that. We need to celebrate the history of Camp Davis and I would like to work together to create a historical center, perhaps as a joint venture with Onslow County, creating a Welcome Center that could be located on Hwy 17. A venture like this could be paid for with grants and business sponsorships and would give travelers an opportunity to stop and learn about our amazing area.

2) What strategy will you implement to respond to public concerns and criticisms?

I will listen to those that take the time to come to us, in person or via email or letters and I will respond with understanding. Too many people feel as if they have been ignored in this community and because of that. they have lost interest in volunteering or attending meetings. This needs to change. The most valuable thing a community has is its volunteers people willing to provide their time, skills and knowledge for free. That is what makes a community great. We need to encourage volunteers to join committees and appreciate them for their time and contributions.

3) How do you plan to measure and evaluate your success in office?

As someone who deals with the community and public daily, I am already privileged to the concerns of many residents and business owners. It will be my honor to do my best to listen and help provide them the information or guidance they require. If we have the right people in the right positions, both in council and as town employees, our work will become easier and less stressful. We need to become a town of "how may I help you? Let me connect you to the right person to help you get that done." We need to create a win-win situation for everyone.

4) Can you give an example of how you have supported a community project in the past?

In 2012 after the purchase of the "Paradise Club" dance hall that was built in the early 1940's, I found a booklet inside regarding the 50th Anniversary of Camp Davis. After noting the date, I realized we were a few years from the 75th Anniversary of Camp Davis. I went to the town hall and spoke about this at a town meeting and felt that I didn't get the response I hoped for or the help that was needed. I took this task upon myself and with my family and a group volunteers from community, put on the 75th Anniversary of Camp Davis that included a street fair (in front of the Paradise Club) vendor booths in the town park and we were able to get the Military to fly an Osprey onto the old Camp Davis landing strip and allowed us to offer tours. With a

generous donation of a bus from the Museum of the Marines in Jacksonville, we had volunteers drive the bus from the street fair across Hwy 17 and onto the Camp Davis landing strip. Jacksonville Daily News covered this event with two front page articles, and it is estimated that 3,000 people attended on that date.

In 2023, I approached the town manager with the idea of Holly Ridge becoming a Bee City, USA. After council approval, a committee was created, and I was selected as the Chairperson. In our first year, our amazing group of volunteers and town employees organized and put on the first Holly Ridge Bee Festival that was a street fair on Sound Road. Our local newspaper, The Topsail Times, featured this festival on the front page and throughout its publication. I was able to reach out to local radio stations and news agencies to spread the word. It is estimated that 2500 people attended the first Bee City Festival in Holly Ridge. Venders ran out of supplies due to the large crowds that attended. The weather was perfect, and the street was filled with friends and music. It was a great day for the Holly Ridge community.

5) What personal or professional experience do you have that makes you qualified to serve your community?

My great uncle Harvey Jones was one of the engineers that designed Holly Ridge streets.

When we purchased the Paradise Club building (one of the last standing structures of WWII Camp Davis) I fell in love with the fact that the road on our corner was Cole Street, named after my great Aunt Elsie Cole. My husband and children were born and raised in Holly Ridge. I remember the amazing Holly Fest that was held the 1st Saturday of November and included a parade that required Highway 17 to be shut down for 30 minutes (could you imagine that today?). I know that this town is capable of so much more. We don't need another 2000 plus homes to define us; we need more festivals and family fun events. We need to encourage more retail businesses. restaurants, medical facilities, and shopping. Why does Surf City have five grocery stores, and we have none? As a North Carolina General Contractor. I hear all the other builders complain about the Holly Ridge building issues, this has to stop. As a business owner I can attest to the fact that it is difficult to bring people to Holly Ridge when we are completely avoidable by traffic going down the island or up Hwy 50 toward Maple Hill. As a community we need to work together to encourage people to visit and shop in Holly Ridge. Having a Welcome Center on Hwy 17 would be a great asset to both our military history and our small, family-owned businesses. This town was once the center of local commerce, bringing some of that back will be a goal.

1) What 3 changes, if any, would you like to see in the community you will be representing over the next four years?

I would re-institute the Ordinance Review Committee, which I was a member of, to allow those members to complete the work that was being done with oversight from the School Government. We need to update our zoning ordinances and our requirements for developments. There needs to be a "builder packet" that provides step-by-step procedures that need to be completed before documents are submitted. We need to have on-line permits to keep things standard across the board, this includes online payments for permits.

Years ago, when I was contacted by the Parks and Recreation committee, that was made up of volunteers including Anna Gaskins and Luann Hooper, I was asked to build a large, covered pole barn in the park to be used as a picnic area. It was done on time and on budget. We built it for the price of the materials and volunteered our labor. This was the park where my children were playing almost daily, and I wanted to make it as nice as possible for them and the community.

5) What personal or professional experience do you have that makes you qualified to serve your community?

I have grown up with many of the

people who still live here today and remember when the town had so much more to offer. We had a grocery store, a furniture store, restaurants, a lumber company, a hardware store, an ambulance, sidewalks, streetlights, a dance hall (the Paradise Club) that was used for beauty pageants, square dances, prom parties, town plays and an auction house. We had a water tower that was located behind the current town hall. We had a racetrack located off Hwy 17 (near Evolve apartments). For my first real job as a young teen, I worked at the Camp Davis restaurant that had walls covered in photos and displays of Camp Davis, not to mention the world-famous Clam Chowder (with Mary Elizabeth Ottaway's secret recipe). I remember when Slim Wilson was the chief of police, and we only had one cop. He was a big man, about 6'4" and intimidating. He kept the marines in line and the kids out of trouble. We had a group of about 30 kids that rode bicycles everywhere and the guys wore blue jean jackets with cut off sleeves. We need to bring back that feeling of a harmonious community.


> Professionally, I've worked in emergency services for just over 21 years, where I've developed key skills in leadership, budgeting, problem-solving, strategic planning, and community outreach.





Caramel Filled Pumpkin Bars Recipe

Filling

11 oz caramel bits 1/4 cup heavy cream

Batter

3/4 cup salted butter, softened

1 cup brown sugar, packed 2 large eggs

2 tsp vanilla

1 cup pumpkin puree 2 cup flour

1 tsp baking soda 1/4 tsp salt

1 tsp cinnamon

1/4 tsp allspice 3/4 tsp nutmeg Preheat the oven to 350F. In a microwave bowl, combine caramel bits and cream. Microwave in 30second increments, stirring in between until smooth. Set aside. Combine butter and sugar and beat until fluffy. Beat in eggs, vanilla, and pumpkin. In a separate bowl, stir together remaining ingredients and add to pumpkin mix. Stir until just combined. Spread 2/3 of the batter onto the bottom of the greased 9" x 13" pan. Pour caramel mixture over the top. Drop the remaining batter over the caramel in dollops and spread out evenly. Bake 22 to 28 minutes.






