

2000 Mules A Film Review

When desperation meets need, a crime is born, and when donkey and horse interbreed, a Mule is born. Stronger than the donkey, more sure-footed than the horse and sterile, mules make excellent carriers of large burdens. Few forces rival the burden of winning an American Election so it is no wonder that when the Elections of 2020 came to a close, some cried foul to a tone-deaf audience.

2000 Mules is a Dinesh D'Souza film that exposes voter 'Mules' by using legally collected geo-tracking data to investigate the potential of fraud in the 2020 elections. Using publicly available marketing information, True the Vote investigator Greg Phillips, tagged thousands of devices and followed their patterns to see if any irregularities occurred around ballot boxes. When irregular patterns, like multiple visits over time, multiple visits to various boxes in



the same day, and visits to non-profit groups started appearing, the team immediately pulled surveillance footage around the ballot boxes.

Pouring over 40 million hours of closed-circuit television obtained with a Freedom of Information Act (FOIA) request, the team presents a case of clear voter fraud happening in America. Individuals shoving, stuffing, and revisiting ballot boxes, ballots falling



Big Developer Versus Small Town Leona Valley

Palmdale City Council Decides

Project Site, Phase 1A, is off of Lake Elizabeth Road, only about a tenth of the whole Ritter Ranch Specific Plan development.

At the April 20th Palmdale City Council meeting, the Council decided to move forward with Phase 1A of the Ritter Ranch Project. The developer, the owner, and many Leona Valley residents attended the meeting with Palmdale citizens as witnesses, "a quasi-judicial hearing," according to Mayor Hofbauer.

The Leona Valley Town Council led by owner Peggy Fuller filed an appeal opposing the project, and the neighbors west of Anaverde and Lazy T Ranch raised a variety of objections. The Specific Plan for The Ritter Ranch Project proposes 10,500-acre, 7,200 home master-planned community on the west side. The first phase initiates construction of 553 single-family residences on 115 acres, including parks and roads.

The appeal cited a lack of timely public notice for the February 10 Planning Commission hearing and a violation of the 30-day notification requirement to the Town Council. Fuller claimed that developers, and the City of Palmdale, made no effort to coordinate and cooperate with residents despite repeated efforts by the Town Council.

Contract Planner for the developer, Eric Norris, denied the existence of a 30day notice requirement, arguing that "everyone knew what was going on."

The appeal also claimed that the 1992 Environmental Impact Report no longer adequately assesses current conditions in Leona Valley. Changes in agriculture, hydrology, air quality, culture, geology, hazards, traffic, recreation, urban decay and more require updates to the report. Questions about sewage, lighting, trash, water, crime, electricity, wildlife, trails, and Native American artifacts remain unanswered. "To build is a privilege, not a right, according to case law."

Promised highway improvements never materialized, such as connecting City Ranch Road to Tierra Subita, and widening Godde Hill Road to four lanes. Karl Pearcy pointed out that since the initial proposal, more than a decade ago, developers failed to meet any of the required traffic safety measures. "Anyone can see the skid marks and oil pans littering Westland Drive." The project would add 18.5 miles of additional vehicles per day, according to Pearcy.

Norris responded that "everything is still the same" since the 1992 report. Developer engineers defended the traffic study, claiming about 5,000 additional cars on a daily basis, with an evening peak of about 450 additional cars.

The official appeal also claimed that the Palmdale Planning Commission dropped essential requirements for a fire station and a library. Norris countered by claiming that the Commission did not drop them, but merely modified them.

Several speakers expressed mistrust in the development process because of broken agreements, like the still undeveloped Anaverde shopping center and other amenities. Developer representatives pointed to the designated commercial area located across from

13.3 Million Dollar, Federally Funded Project

Press Release from the City- Avenue R Complete Streets & Safe Routes to School Project to Begin May 4

Construction work began on the Avenue R Complete Streets and Safe Routes to Schools project in May 2022, which will bring needed improvements along Avenue R from Sierra Highway to 25th St. East.

The 13.3 million dollar, federally funded project will widen Avenue R, create walkable routes with sidewalks, install class II bike lanes, increase overall safety for all road users, improve signalized intersections, and will aesthetically enhance the corridor. Improvements will also be made at the intersection of Avenue R-4 and 11th St. East (the entrance to Tumbleweed Elementary School).

Construction will take up to two years to complete and will be phased to limit road closures along Avenue R. Motorists should expect traffic delays and are encouraged to use alternate routes.

"The Avenue R corridor is one of our City's main thoroughfares and these improvements have been a long time coming," said Palmdale Mayor Steve Hofbauer. "We have worked hard to acquire the funds needed to bring it up to the standards in terms of safety, access, and function that our residents need and deserve."

Lazy T Ranch.

Palmdale residents expressed mixed opinions, citing a shortage of housing, but believing that Leona Valley residents' issues should be addressed. Jason Zink urged the City Council to apologize for city staff's treatment of the Town Council. "We always stood for towns. We need housing but Palmdale should be creating partnerships."

Mayor Hoffbauer conducted his own study of fire response times to Ritter Ranch, with the closest station on Rancho Vista. "We can build it, but staffing could be a problem." The county cannot currently support a new Ritter Ranch station.

Council members addressed the need for a suitable agreement. Laura Bettencourt wondered whether a Sheriff substation should be considered for public safety purposes.

Austin Bishop observed, "It sounds like you are in the process of meeting in the middle with the Town

Council. It doesn't sound like you're there yet. I am very pro-development but I do believe we need to be as responsible as possible when we do develop but once it's built, it's done, and there's no going back." He urged all parties to reach an agreement and document it in writing.

Richard Loa suggested tabling the item for two weeks, echoing Bishop, "An oral agreement isn't worth the paper it's written on." Hoffbauer warned the developers that they must return to the Council for any additional approvals. Without assurances, it becomes, "talk is cheap." Despite numerous unresolved concerns, the Council approved the agenda item with Loa casting the only dissenting vote.

More than other areas of Los Angeles County, Palmdale faces multifaceted development concerns. This meeting detailed only a few of these complexities. onto the floor at times from the rushed nature. Video after video of the same culprits putting envelopes into the box at 3 am, 1 am, 4 pm, in front of lines of people waiting to vote legally. Conveniently, the State of Arizona turned off cameras on ballot boxes. Wisconsin, contrary to the law, does not have cameras on any of their boxes, and Fulton County in Georgia claims surveillance video of ballot boxes does not exist, leading to more questions. importance of geospatial data is especially highlighted where video does not exist of a crime being committed.

After Arizona indicted an individual of stuffing ballots by linking fingerprints to the culprit on Dec 22, 2020, video

surveillance the next day shows gloves on every mule. True the Vote tested the ability of geo-tracking using purchased data to investigate a homicide. By providing important data to authorities they lead to the arrest of two gang members linked with the murder of eightyear-old Secoria Turner. One anonymous mule admitted to being paid per vote and was told to drop off the ballots at the box near the library because there are no cameras there.

While CNN, FOX, MSNBC, and other outlets proclaimed 2020 "the most secure election" in history, video uncovered by Salem Media challenges the narrative. Thousands of people participated in blatant cheating of the elections for a price, some violations in public view. Project Veritas was silenced by the New

York Times and blamed for selective editing when it exposed a ballot harvester bragging about his activity on Snapchat, but anyone who had a suspicion of fraud in 2020 is a sore loser and a conspiracy theorist. Thousands of mules disbursing hundreds of ballots over time can change an election.

Law enforcement has the authority to investigate, but the people have the duty to safeguard elections. Contact your local Registrar's office to become a poll watcher, demand cameras on your ballot boxes, and regular monitoring. Elections have consequences for everyone, but for those who are involved, elections are a chance to participate in the direction of the community. 
Selected artists will be notified by 8 if their art has been accepted. Artists will be asked to drop of their art to the Palmdale Playhouse on Aug. 15



What is SMART-Tag?

On October 19, 2021, at a routine meeting of the Board of Trustees, Jullie Eutsler announced that Antelope Valley School Transportation Agency (AVSTA) will be ready to kick off the Smart Tag program by November 1st. The software program will allow the transportation agency and the school district to track the kids on the buses. Paperwork will be sent out to students and schools. AVSTA hopes to have the tags distributed and functioning by January 1, 2023.

According to the web presentation on the Palmdale School District's website, each child from kindergarten to high school will be issued an RFID tag. RFID is a technology similar to bar codes. A boarding student will present their card to the RFID reader. The SMART Tag tablet will confirm the student is at the right place. When getting off, the student will again scan their card to ensure it's the correct stop. Information gathered by the driver tablets will be shared in real-time using secured cloud technology.

SMART tag[™] Parent Portal to help keep unequivocal no. them informed when their children ride the bus. Parents can turn on SMART Alerts to let them know when the bus will arrive at their child's stop in the morning and afternoon. Parents will have access to

their child's riding history, down to the location, date, and time. And they can view a live map of the school bus both before and after the child has boarded

According to the video presentation, an additional parent can make a "coparent" account. The primary parent, or account originator, will be notified that a secondary account has been created. However, there is no indication whether the primary account holder will be able to limit the co-parent's access to the child's whereabouts or block them out altogether.

This could be problematic for many single-parent families, raising legal and safety concerns. Ex-spouses who are under a restraining order or who have had their visitation rights revoked could potentially have unlimited access to a child's location.

At the Lancaster School District Board Meeting, where the SMART-Tag was also introduced, an attendee asked the council if this was a voluntary program and whether parents or students could Parents will have access to the opt-out of it. The answer was an

Recycling is important to help keep trash out of our beautiful desert. It isn't just about putting your plastic, paper, and glass all in the green bin. It is also taking your old mattresses, crusty paints, dead batteries, electronic devices, and motor oil, to a facilities that will repurpose them. Here in Palmdale there is a facility where you can drop off most garbage for free! On the first and third Saturday of every month you can bring in electronic devices so that they can be properly disposed of to Valley Environmental Antelope Collection Center (AVECC) on 1200 W. City Ranch Road in Palmdale. If you have any solvents, fluorescent light bulbs, propane tanks, or chemicals, take them to AVECC. If we don't dispose of chemicals properly they can contaminate our water by getting into our drains and seeping into

our ground water.

Checking to see if plastics are also make a big impact. To find out whether a plastic is recyclable, simply find the triangulated number usually located on the underside or bottom. If the plastic has a number 1 or 2 they can be put into the green bin, but number 3's can low chances of being recycled. So when buying try to see if you can buy 1 and 2 rather than anything else. Recycling styrofoam inefficient so try to reduce purchasing it. When recycling bottles, make sure you rinse out any thing left behind before puting it in the bin because a little bit of food or soap can make a difference in whether it gets recycled.

Lastly, repurposing household trash can be a great alternative. Finding DIY videos for plastic bottles and other garbage on the internet helps reduce waste. These projects are engaging, creative, and just plain fun. Turning old pots and colanders into planters is a cute way to bring a new life to something you might have thrown out. You could spray paint cans and use them to hold cutlery at a themed party. There are so many ways to upcycle old trash. Find a way that works great for you!

Informed Consent: The Shot In The Dark

What if I told you there was more to the Childhood Vaccine Schedule than what you are being told? What if I told you that most doctors and physicians across the country have failed to disclose the safety of childhood vaccines? The answers to those questions are what drove Candance Owens to create a documentary called, The Shot In The Dark, which can be found on Parler. This documentary consists of 11 episodes, which outline the history of every childhood vaccination on the schedule. Through the analysis of medical data, statistics, interviews with doctors, and verbiage found on vaccine inserts - Owens presents a compelling case behind the truth and safety of vaccines. Additionally, she brings awareness to the fundamental right of patients – informed consent.

According to the National Library of Medicine, informed consent is the process in which a health care provider educates a patient about the risks, benefits, and alternatives of a given procedure or intervention. If a patient is a minor, then the parent must grant informed permission based on the same process.

Vaccines, according to the National Library of Medicine, are defined as a minor medical procedure. Therefore,

shouldn't this procedure, like all other medical procedures follow the same suit? Shouldn't their questionable ingredients, lack of testing, and possible side effects such as death, be openly discussed? Why aren't more doctors being transparent during wellness visits when advocating or administering vaccines? Why aren't both sides of the scale being disclosed? Moreover, why aren't doctors providing parents with the manufacturer's package insert so they may openly review and discuss any concerns? While only doctors or physicians can answer those questions, it is time for parents to start asking them.


When making informed decisions regarding the vaccination schedule, there are a few things we must start to understand. First, vaccine manufacturing companies with special government contracts are released from any liability relating to vaccine injuries. Therefore, vaccine manufacturing companies cannot be sued directly if any vaccines harm you or your child.

Furthermore, parents must realize that a vaccine, for example, Vitamin K which is administered at birth, contains a black box warning label which can be found in the manufactures package insert. A black box warning label is the strictest and most series type of label given by the FDA.

In addition, vaccine inserts clearly state that they have not been evaluated for cancer-causing organisms, mutations, or fertility impairment. According to the October 1, 2021 Data & Statistics report from the U.S. Health Resources and Services Administration (HRSA), the total compensation awarded under the National Vaccine Injury Compensation Program (VICP) has now surpassed \$4.6 billion. Vaccine injuries are real, and more awareness should be brought to those injuries.

Candace Owens also sheds light on the pushback that parents have encountered when declining vaccines for their children. Parents are starting to feel hesitant and unsettled with the increase of vaccinations being put on the schedule and rightfully so. In 1962, by the age of 18, children were only required to have a total of 5 doses. Fast forward to 2022, the number has risen to well over 75 doses. While more vaccines continue to be manufactured and added to the schedule, there must be an intentional dialogue between health care providers and patients.

Informed Consent can only come about when both risks and rewards are



disclosed equally and unbiasedly. Every patient has the right to assess a medical decision without being coerced, harassed, or threatened. Too often it is forgotten that doctors work for their patients and not the other way around. Patients have every right to ask questions to better understand their medical care. Most importantly, parents have every right to decide what they want their kids injected with -without fear of government interference.

Whatever way you are swayed, whether it be to get vaccinated or not the most important thing is that you can make an informed decision which leads to informed consent. Till next time.... Denize Verduzco

Lobby Day in Sacramento

Lobby Day was sponsored by Pastor Jack Hibbs, Capitol Resource Institute, California Family Council, and Real Impact at the State Capitol in Sacramento, CA on April 19th. According to RealImpact.us, A.B. 2223 changes California's abortion law by legalizing infanticide. The bill states that "a person shall not be subject to civil or criminal liability or penalty, or otherwise deprived of their rights under this article,

based on their actions or omissions with respect to their pregnancy or actual, potential, or alleged pregnancy outcome, including miscarriage, stillbirth, or abortion, or perinatal death due to a pregnancy-related cause."

Arrangements were made. The 9:00 am lobby training session was packed and two more sessions followed. Surrounded by a sea of people, I estimated that 3000+ were in attendance. Many of those were families, children, and grandparents. All age and ethnic groups were represented and many held signs in protest against this bill. At 9:43 am, it was announced that the legislative offices were closed to the public. Never in the history of Sacramento has there been such an outpouring of opposition against any bill. Around 10:30 am it was confirmed by the CHP that the offices were again open. The People Convoy showed up as well to support our efforts. There was encouragement from an 11:00 am press conference with many PRO-life speakers.

At the actual capitol building, the representatives had red or green lights on their doors to show availability and people lined up around the building to talk with them. 90% of the doors were red-lighted (closed) with a sign that said to contact them by calling or email. Our representatives did not want to speak directly to the people they represent. Locked out, constituents slid notes under their doors to communicate with them. Dejected, I left a few notes to encourage opposition to this bill.

On the other side of the building, there was a praise and worship band playing, people waving flags, praying, singing, and dancing before the Lord. Spiritual warfare was happening! The People's Convoy joined in as well on their horns. I believe we haven't seen the end of this fight.

"If at first you don't succeed..." Someone once said that no homeschooler ever failed a subject, insinuating that with mommy doing the grading, who could? But other factors, like patience may be involved. Standard curriculums dictate when a topic is introduced, set aside, and student fails to grasp the topic during that period, he's out of luck.

Not so with homeschoolers. There are classroom, or the pressure of shuffling children off to the next level. What's important is that the lesson is learned, regardless of how long it takes or how many different methods are tried. The principle of education is absorption, not a test score.

Have a "Proud Parade". Your homeschool parent effort is recognized by the state as no small endeavor. The California government spends \$14,174 annually per pupil, with lower-income Take them in stride. Homeschool districts paying \$1,991 more on each student than wealthier districts. In the private sector, the average yearly tuition for private schools is \$15,642.

> A homeschooled child's education is measured not so much in dollars as in love and gray hair. Yet the number of parents willing to embark on that journey has never been higher. In the spring of 2019, 5% of American children were homeschooled; today 11% are, a rise across all demographics. The number of enrolled kindergartners is dropping by the tens of thousands.

> Against the backdrop of the nation, these figures may seem insignificant, but the homeschool community is a tightlyknit, burgeoning with ideas, diversity of thought, ideology, and goals. If you look around at the people standing beside you, and the pioneers who cleared the way, you will find that you have every reason to be proud. You are in good company.

Palmdale History: Part Two

Continuing our story, it is recognized that many have not lived here enough to witness the radical transformation Palmdale has undertaken from being a rural city to the 6th largest city in Los Angeles County. While the city was yet dark, ghostly, and without form, a group of 50-60 families was the first to settle in it. As the story goes, this group of German and Swiss settlers was told that when they found palm trees, they were close to the ocean. The settlers mistook Joshua trees for palm trees having never actually seen palm trees before. They built their settlement along the foothills where they first came into the valley. However, while the story is nice for the folklore of the town's creation, there is no way to historically verify its validity.

As we stand and see the great advances and how much has been established, we owe much of our foundation to two notable towns: Harold and Palmenthal, which in German means Palm Valley. The town of Harold was located along the foothills, around the area of Sierra Highway and Barrel Springs Road. The Trego post office was located near the Alpine station of the Southern Pacific Railway. The Alpine Station was a major transportation hub for the railroad until it was moved in 1892 causing the eventual demise of Harold. Next time you are on Sierra Highway, look out for the remnants of the town such as the streets that are, to this day, named after the town; Harold Beech, Harold Ash, Harold First, Harold Second, and Harold Third. Additionally, parts of Old Harold Road can be seen from 25th Street east and Barrel Springs Road which would have led, at one point, to where the town of Harold was.

The nearby town of Palmenthal was where the settlers set up their first Lutheran church. Almost all traces of the town of Palmenthal today are gone except what is known today as the old Palmdale cemetery which is located at the corner of 20th street east and avenue S. The Palmdale Cemetery used to be the cemetery for the town pioneers. This historical landmark is now closed to the public and can only be entered by contacting the proprietor of the land which is believed to be the City of Palmdale. Apart from the cemetery, the original school which sat near 27th Street East and Avenue R-8 still exists and was given to the City of Palmdale in 1980. It can be seen at W.J. McAdams Park on 30th Street East. It is believed that Palmenthal was torn down so that the Palmdale we know today can be built.

In the next issue, we'll discuss how Harold and the short-lived town of Palmenthal were the seeds of creation for Palmdale. The attempted settlement of these cities is what helped to determine what would work in order to be able to build the long-lasting city that many call home today. See you next month.

The Human Connection: Brain Boost

May is Mental Health Awareness Month and while many people will bring attention to the importance of getting help via therapy, counseling, and prescription drugs, one important aspect seems to go under the radar which is the significance of proper nutrition.

Nutrition plays a vital role in mental health but only in the last 20 years has this become a more heavily researched topic in the psychology and health-science world. After mountains of test studies and observations, psychologists and scientists alike discovered an undeniable link between mental health and nutrition, and thus, Nutritional Psychology (NP) was born.

NP is the study of nutrition and how it pertains to mood, behavior, and mental health. Nutritional Psychologists look at the ways food influences psychological, behavioral, cognitive, perceptual, sensory, and psychosocial patterns. The goal of this particular area of study is to implement education and nutrition to connect diet with mental health. NP gives mental health professionals another important piece of a puzzle by helping clients understand how and why they should use food as a tool to improve the way they feel.

The connection between proper nutrition and neurological development starts very early in life. In fact, studies have shown that protein and omega-3 fatty acids taken during the second and third trimester of pregnancy act as critical building blocks for the fetal brain, neurological, and retina development. Fetal brain growth is at its peak in the second half of pregnancy, and the rate of growth continues during the first year of life and on for the next several years. Remember what Mom used to say about eating all of your fish and vegetables because they're good for you? Well, apparently she wasn't just being mean, she was trying to keep your brain functioning at peak performance!



If you or a loved one are suffering from mental illness it's important, first and foremost, to speak to a trusted family member, friend, pastor, teacher, counselor, psychiatrist, or physician. For many people, this is incredibly helpful and relieves a lot of stress, anxiety, depression, and misdirection, but sometimes the solution lies in responding to a physical need more than an emotional one. A physician or naturopathic doctor can check for hormone imbalances as well as vitamin deficiencies through simple blood work. They can determine from there if more testing needs to be done.

Most Nutritional Psychologists will agree that avoiding the following foods may reduce mental health issues such as depression, anxiety, and memory loss: refined sugar, artificial sweeteners, alcohol, hydrogenated oil, energy drinks, and processed foods.

NPs will also agree that the following foods can be very beneficial for brain function: green, leafy vegetables, such as kale, spinach, and broccoli (these are loaded with brain-boosting nutrients like vitamin K, lutein, folate, and beta carotene), and next on the list is fatty fish, such as salmon, cod, tuna, and pollack (these contain omega-3 fatty acids which are great for combating Alzheimer's disease). Flaxseeds, avocados, and walnuts are other sources of omega-3s if you're not a fan of fish. Berries, such as strawberries and blueberries, contain flavonoids, which have been known to help with memory. And many will be happy to know that studies have shown that caffeinated tea and coffee, in limited quantities, can actually help boost short-term concentration and memory. Spices, like turmeric, fermented foods, and dark chocolate are also very beneficial for brain health.

So the next time you're feeling a little "off" mentally, it may help to take a closer look at your daily food consumption and ask yourself... do I need a nutritional brain boost?

free, and profitable business, Rebel News Corp., because the bank does not align politically with the media agency. Amid tensions with Ukraine; Visa, Mastercard, Paypal, and American Express suspended transactions in Russia forcing Vladimir Putin to push the U.S. Petrodollar aside for Russian currency.

As more and more corporations sequester from "radical right" or "conservatives," new markets are emerging. Etsy is giving way to Lexxi and other marketplaces while media companies, like Daily Wire, have cut ties with unfriendly sponsors, such as Harry's Razors. New commerce is insulating from "cancel culture" by creating revenue streams of their own.

The great shutdown of 2020 witnessed small businesses doing anything to survive, from moving hair salons outside to having patrons eating in the parking lot. County health officers issued violations pressuring new regulations and removal of health permits, which caused some businesses to close their doors temporarily and others to close forever. Defiant businesses invested in dark curtains, told clients to park away from the entrance, or

only took reservations to keep employees paid. Owner, Angela Marsdsen of Pineapple Hill Saloon in Sherman Oaks, made headlines when she exposed the hypocrisy of her bar and grill being unable to serve patrons outside, per county health orders, while a movie company set up catering for their own workers in front of her restaurant.

Labor shortages plague the marketplace, meanwhile prices for goods and services rise across the country. The attitude of self-segregation percolates into daily life as some employers report prospective employees are refusing to work with unvaccinated staff or patrons as a condition of employment. To the contrary, staffing agencies like WorkSource, funded by the state of California, are requiring individuals to have received vaccinations to even be considered for job placement.

Separated societies quickly polarize when one group takes their talent to another playground and experience success. Free markets need freedom of choice, including the choice to stand apart. Health department grades boost a business's status, but unless the

establishment is in gross violation of public health standards such as unclean kitchens, tools, and water, the department should not be involved in day-to-day affairs. The Amish sell wares to the public without labor laws or OSHA standards. Escape or engage: Can consent of the governed return to California?

Last year 350,000 people escaped California. According to the 2019 Berkley Institute of Governmental Studies poll, more than half of California voters seriously considered it. In the past when the government encroached on daily life, Californians voted in limited government fiscal conservatives like Ronald Reagan and Pete Wilson. When skyrocketing property taxes threatened to evict retirees from their houses, the people themselves passed Proposition 13 to keep them home. What happened to the California dream, the envy of the world, the fifth largest economy on the planet? Put simply, elected officials started ruling over the people rather than serving them.

Representation in Sacramento no longer reflects party affiliation. Approximately forty-six percent of all voters register as Democrats yet they control an eighty percent of the votes in the State Senate and Assembly. If a Republican governor took office and vetoed any bills, the current legislature could override the veto. Yet, Republicans and Independents together account for forty-eight percent of all voters, more than registered Democrats.

The citizens of California saw the hypocrisy in Sacramento when Governor Gavin Newsom defied his own emergency COVID lockdown orders. Citizens recorded him throwing a fancy dinner in Napa Valley for confidantes

and supporters; no masks, no distancing. Videos show him dropping off his unmasked kids at a high-priced private school. Parks across the state closed down, except for the ones he frequented. When he started construction on a new mansion in El Dorado Hills, El Dorado county magically dropped their COVID restrictions. The people collected more than two million signatures to recall him, the most in history. Yet, he fended off the challenge with a decisive sixty-one percent of the vote.

Members of the ruling party seem confident of retaining power, even when the people vote against them. The legislature passed laws that exposed the entire election process to fraud, taking advantage of COVID to hand fraudsters a gourmet menu of ways to cheat. Vote traffickers love outdated voter rolls, legalized ballot harvesting, mail-in ballots for every voter and unmonitored dropboxes. Any unused ballot became fair game to cast illegal votes. Just fill out a ballot and sell it to the highest bidder. Numerous voters reported that when they attempted to cast their vote on election day, poll workers told them they had already voted by mail.

Envelopes containing vote-by-mail ballots identify the registered voter, but the ballot itself does not. County clerk office staff can replace mail-in ballots for any reason by "copying" the votes onto a separate provisional ballot to be officially

counted. Over 600 thousand provisional ballots were "copied" in Los Angeles County during the 2020 election, more than enough to decide the majority of races. Once the ballot leaves the envelope, altered votes cannot be traced.

The constitutional sovereignty of all Californians depends upon connecting one legal vote to each legally registered voter. As Rachel Hamm, 2022 candidate for California Secretary of State, puts it, "Californians deserve to know that their elections were and are free and fair."

Free and fair elections put the people in charge; Democrat, Republican or Independent. Hamm proposes seven essential reforms: require voter ID, restore paper ballots, eliminate mail-in fraud, single day voting, clean up voter rolls, reform poll watching, and regular election audits. All of these measures would drastically reduce the potential for election fraud, ensuring that the power stays with the people.


Though the Secretary of State serves as the chief election official in California, an election fills the seat. Under current laws voters cannot know whether the official overseeing elections won the position or purchased it. Open hypocrisy by Newsom and other elected officials signals disregard for public opinion. What the people think no longer seems to matter.

Simply casting a ballot during an election no longer ensures that those in power will govern by the consent of the people. To hold elected officials accountable, the citizens themselves must engage to ensure election integrity. Fraud can be exposed if enough concerned California citizens vote and take responsibility to monitor every aspect of the election.

To engage in government again voters must set aside personal priorities for the



good of all Californians. Vote early to make sure your own vote beats harvester votes to the counting center. Vote in person and turn in you mail-in ballot at the polling place, unopened if possible. Volunteer to be a poll watcher. Lead or join an organized group of citizens monitoring drop boxes, mailboxes and harvesters in retirement homes and elderly care facilities. Request and review the voter rolls, reporting people you know who can no longer cast a valid California vote.

Each California citizen must choose whether to escape to another state, or engage in self-governance. If enough citizens engage, the consent of the governed can be restored to California.
