# The Darkside of boxing!

Boxing can be a dangerous sport with potential health risks, including injuries and other challenges:

### Injuries

Boxers can suffer from a variety of injuries, including concussions, cuts and facial blows, hand, finger, and wrist injuries, muscular injuries, ankle sprains, and dislocated shoulders. These injuries can be minimized by following rules and regulations, using protective equipment, and training properly.

### Trainers' financial challenges

Trainers often have verbal or handshake agreements with boxers and promoters about their financial cut, and they may not get paid until after the boxer receives their purse check. This can cause anxiety, especially after a loss, and some of the best trainers have been stiffed by more than \$100,000.

### Mental health

Some boxers may experience mental health issues after retiring from the sport, such as dementia

# **People ask why 6** round titles? **By Staff:**

It has been up time after time and these are the reasons why the **American Boxing Organization** has decided since 2014 to make 6 round titles.

As we all know all World titles WBC, WBA, WBO,IBF and IBO are 12 rounds. They dropped it after the Duku Kim vs Ray Mancini in the 80's where safety became a real serious topic. So, then it was proposed and later adopted by all.

Now, since most titles are fought and competed for 12, 10 and 8, we felt since we are a continental title, we should put other safety factors by reducing the amount of rounds and adapt what some states allow, therefore since we are a 10 round title our title paradigm is the following:

American Regional 6 to 8 rounds providing the state allows it.

Americas, North and South American and Continental titles will be following The standard 8 and 10 round model. This simple formula has allowed us to safe guard and increase longevity in the ring and after boxing. Our standards have been accepted by the following states that allow 6 round title. Texas, Indiana, Kentucky, Wisconsin, W Virgina, Washignton D.C and the Tri States.


