

It's a new year, that means new we have new adventures to take and new memories to make. It's a new chapter of possibilities and opportunities.




## Learn to make a Ribbon Skirt





#### Boozhoo,



Most of you know me. Who you should vote for? Many have said, "why is there continual fighting between Ogema and council?" "Change the Ogema or certain council members, or just change everyone? I leave that for you to decide, but suggest two documents to review so you can make informed decisions. Documents to review are; LRBOI COURT CASE #20-051-AP and HARVARD LAW REVIEW- Tribal Executive Branches: A Path to Tribal Constitutional Reform; located on our tribal website. The last four years have been difficult.

The first issue was the above court battle, started in August 2016 ending in May 2001. Court dealt with "separation of powers" which has been a focus of conflict between every Ogema and council over the years. The good news is clear lines have been drawn for branches to follow, moving us in the right direction going forward.

The second issue, the Muskegon casino project; a 12+ year project, cleared by the Department of Interior in 2020 moving forward to Governor Whitmer's desk for signature. She declined to sign based on GRB's attempt at getting federally recognized. At this writing, our opportunity for a casino is still in limbo.

The third issue was world-wide, COVID. It affected all families, income, and businesses. Many businesses were shut down, some permanently. Our casino shut down two times. The good news? We are back up and running almost at full-force. Our numbers continue to return. I wish you the best in your candidate selection. Miigwetch



## TACTICAL TREATS

USCCA Accredited CPL Instruction

#### Weekly Classes

#### Basic Hand Gun knowledge & Cleaning

This class will show the student the differences in Hand Gun calibers, their uses & effectiveness. There will be no live ammunition in class! (snap caps only) Basic mechanics of how most hand guns function.
