# **Sturgeon Release**

BROWN TWP. — For nearly two decades, the Little River Band of Ottawa Indians has worked to restore an ancient and endangered fish to Manistee waters.

On Saturday, nearly 60 young nmé, or lake sturgeon, were released into the Manistee River's Rainbow Bend near the tribe's streamside rearing facility.

The Little River Band of Ottawa Indians has been committed to this project of slowly building up the sturgeon population with these annual plantings. The release is part of an environmental and spiritual commitment to the fish and their habitat.

Fingerlings that were reared at the facility were released in a ceremony on Sept. 10, and could survive in Manistee waters for over a century.

Around 56 young sturgeon, ranging from 6-9 inches long were handed to attendees and released after a prayer was given. According to the U.S. Fish and Wildlife Service, male sturgeon can live as long as 55 years old and females can live up to 150 years old.

The LRBOI Natural Resources Department began its streamside sturgeon rehabilitation program in 2004. Archie Martell, the Fisheries Division Manager for the LRBOI Natural Resources Division said that the small fish have around an 80% survival rate in the wild. Young sturgeon are collected from the wild in spring and early summer, then reared in the facility until they are mature enough to be released, according to Martell. There, the young fish are safe from natural predators and can be acclimated to their home waters that are pumped from the river into the holding facility.

"We have a few fish at our facility this year that we collected back at the end of May first part of June, reared them up to this point (and) gave them everything we could to give them the best head start we can," Martell told those in attendance.

Before the release, people were invited to see the facility where the sturgeon were reared and were able to interact with the fingerlings.

Larry Romanelli, Tribal Ogema of the Little River band

of Ottawa Indians credited the dedication of those working for the tribe's fisheries division.

"This is important to me. This is important to nature and the reconnection of everything," Romanelli told those in attendance. "I really want to (applaud) our natural resource department, and all the partners that go into this. It's a huge amount of work, that they're out there in the middle of the night collecting eggs."

Out of roughly 2,000 collected specimens, Romanelli said that only the 56 had survived to the point where they could be released. In prior years, as many as 300-400 individuals had been released into the Manistee River.

The Big Manistee River watershed may once have held one of the largest sturgeon populations in the Lake Michigan Basin, according to documents from the LRBOI Natural Resources Division.

Like other sturgeon, these fish are an ancient, semi-cartilaginous species recognized by bony plates on the sides and back. As bottom-feeders, the sturgeon use an elongated spade-like snout to stir up sediments on the bottoms of lakes and rivers while feeding, according to the U.S. Fish and Wildlife Service website. They have been known to grow over 7 feet long and can weigh up to 240 lbs, according to the Wisconsin Department of Natural Resources which measured the record lake sturgeon in 2012.

Romanelli noted that many of those in attendance were experiencing the ceremony for the first time. "When I see these young kids, and I watch them place the fish in the water — that fish may be around for 100 years. So they may grow with you," Romanelli said. "You may see them again in your lifetime, and that means a lot."

# MONARCHS ENDANGERED

The migratory monarch butterfly is listed as endangered by the International Union for Conservation of Nature (IUCN).

The famous monarchs are the only butterflies known to make two-way migrations, according to the U.S. Forest Service and it takes several generations to complete each leg of the journey. To escape harsh winters in the northern U.S., monarchs can travel nearly 3,000 miles to reach the California coast, Arizona and Michoacán state in Mexico

The monarch butterfly is found in nearly all of North America, but today it faces threats from habitat destruction and climate change. Part of what makes these butterflies so vulnerable is that they migrate thousands of miles each year to California and central Mexico.

Scientists point to climate change as a growing threat as dramatic weather events such as hurricanes and droughts become more frequent along the monarchs' southern migratory routes. The use of herbicides and pesticides for farming are also factors in the decline of the monarch. Habitat loss from legal and illegal logging and deforestation to make way for agriculture and urban development have already destroyed significant areas of winter refuges for the migratory monarch butterflies in Mexico and California.

To help increase the number of monarchs, scientists and conservationists are recommending planting more milkweed and nectar flowers, maintaining forests and limiting the use of pesticides and herbicides in the butterfly's range.

#### **Doing our part**



This past July the LRBOI Education Department continued its annual monarch butterfly raising. The education department provided monarch caterpillars for tribal citizens to raise until they were ready to be released as monarch butterflies.



- In order for a Registered Voter's votes to be counted in a given Election, completed Mail-In Ballots must be received by the Election Board at its mailing address before noon on Election Day. It is the responsibility of the Registered Voter to verify that his or her ballot is mailed in a timely fashion to meet the established voting deadlines
- The Primary Election will be conducted by secret mail in ballot only. The homes of registered voters shall be designated as polls for voting purposes. All Tribal Members who turn 18 years old by the date of the election, will be considered a Registered Voter, and will receive a ballot.
- Ballot counting will begin at 12:30 pm, on Friday, April 28<sup>th</sup>, 2023. The ballot counting will be held in the Lodge at the Tribal Government Center, 2608 Government Center Drive, Manistee, MI.
- If the Tribal Member or individual wishes to have their photograph and biography included in any Election Board or other Tribal Government sponsored informational materials concerning the Election, the Election Board Website, Election Board Facebook page, and mailing or posting of the tribal communication, then he or she must include the photograph and biography in their Candidate packet. Any Tribal Member who is running for elected office must obtain, complete, and submit a "Declaration of Candidacy Packet" during the period listed in the Election Calendar below. Any incomplete packets received and not completed before the deadline will result in ineligible status.

- In order for a Registered Voter's votes to be counted in a given Election, completed Mail-In Ballots must be received by the Election Board at its mailing address before noon on Election Day. It is the responsibility of the Registered Voter to verify that his or her ballot is mailed in a timely fashion to meet the established voting deadlines
- The Special Election will be conducted by secret mail in ballot only. The homes of registered voters shall be designated as polls for voting purposes. All Tribal Members who turn 18 years old by the date of the election, will be considered a Registered Voter, and will receive a ballot.
- Ballot counting will begin at 12:30 pm, on Monday, December 12th, 2022. The ballot counting will be held in the Lodge at the Tribal Government Center, 2608 Government Center Drive, Manistee, MI.
- If the Tribal Member or individual wishes to have their photograph and biography included in any Election Board or other Tribal Government sponsored informational materials concerning the Election, the Election Board Website, Election Board Facebook page, and mailing or posting of the tribal communication, then he or she must include the photograph and biography in their Candidate packet. Anyone who does not submit a biography and photograph will have their name listed with an indication that the biography and photograph was not submitted. *\*Due to time constraints, Special Election Board Facebook page.*
