## Coming Soon!

### **Wahlburgers Favorites Outlet Opens at the Chicken Ranch Casino in Jamestown California.**

Wahlburgers Favorites will open at the Chicken Ranch Casino Resort in 2024 that is owned and operated by the Chicken Ranch Rancheria of Me-Wuk Indians in Jamestown California.

The restaurant became the first Wahlburgers restaurant to open in the state of California under the sub-franchise agreement between the restaurant chain and NativeWahl, a subsidiary of Little River Holdings, the economic development corporation of the Little River Band of Ottawa Indians Tribe, base in Manistee, Michigan.

Wahlburgers is a casual dining burger restaurant founded by brothers Mark, Donnie, and Chef Paul Wahlberg.

Heading the effort for the Chicken Ranch Casino Resort is Chairman Lloyd Mathiesen, the Chairman of the Tribe.



# Why Recent Wahlburger Closures Don't Affect NativeWahl?

During Covid the world changed in several ways, the restaurant industry is no different. The issue does not lie in the quality or popularity of the Wahlburger Restaurant instead it lies in staffing shortages, increased rental fees, and the changing nature of the restaurant industry. These changes can be seen in the Hy-Vee Wahlburger Locations. In an article published on March 12, 2020, in Supermarket News the Midwestern grocer Hy-Vee aims to discontinue the 21 full-service Market Grille restaurants they have by converting them into Wahlburgers fast-casual restaurants. Within the article Hy-Vee is quoted as saying "Our customers are wanting more fresh and convenient meal options. Our 21 Hy-Vee Market Grille full-service restaurants will transition to casual, counter-service Wahlburgers restaurants by early summer," (Redman, Russell.) In 2023 Hy-Vee Wahlburger Locations make another shift in how they operate which is discussed in an article by Linh Ta published on January 18, 2023, by Axios Des Moines. Ta's article states that Hy-Vee made the decision to close its standalone stores and only open restaurants connected to its grocery stores from now on due to staffing challenges and the changing nature of the restaurant business.

Little River Holdings and NativeWahl are taking a similar approach as Hy-Vee in 2023. NativeWahl LLC which owns the rights to own, operate, and sub franchise Wahlburger Restaurants to any tribally owned property in the United States and Canada. When Little River Holdings LLC and the Wahlburgers announced their partnership Eugene Magnuson was quoted saying "There are a lot of tribes that have significant offerings in food and restaurants — some of them have up to 20 or 30 locations within their tribal properties," in an article published July 16, 2021, in MiBiz by Jayson Bussa. NativeWahl locations will primarily be in casinos or on highly populated reservations that are looking to change-out existing restaurants and or expand their dining options. This provides us the opportunity to have successful locations much like Hy-Vee has seen with their Wahlburger locations that are within the grocery locations.

# LINE 5 UPDATE


## UN Expert Calls on Canada to Shut Down Line 5 Oil Pipeline

GENEVA, CH — This month, an international human rights expert appointed by the United Nations Human Rights Council released a report in which he recommends that Canada “cease construction or operation of the Coastal GasLink, Trans Mountain and Line 5 pipelines, until the free, prior and informed consent of the Indigenous Peoples affected is secured.”

The report also states that prolonging the operations of Line 5 oil pipeline “is inconsistent with its international commitment to prevent and mitigate the effects of climate change by phasing out fossil fuels.”

The report reviews the situation of Indigenous Peoples in Canada, based on the information gathered ahead of and during an official country visit to Canada by the Special Rapporteur on the rights of Indigenous Peoples, which took place in March.

The recommendation comes after years of advocacy by Indigenous communities in the US and Canada affected by Line 5. It echoes another recommendation from the UN Permanent Forum on Indigenous Issues (UNPFII) in April calling on Canada to “re-examine its support” for the pipeline and recommending that “Canada and the United States decommission Line 5.” The UNPFII declared that the Line 5 “jeopardizes the Great Lakes” and “presents a real and credible threat to the treaty-protected fishing rights of Indigenous Peoples.”





In response to this report, Whitney Gravelle, President of Bay Mills Indian Community, said:

“This report further condemns the existence of Line 5 throughout Indigenous territory, on both sides of the border. We urge the Canadian government to revoke its support for Line 5 and support Tribal Nations and the State of Michigan in shutting this pipeline down before tragedy strikes and creates an international incident. We remain committed to protect our people and treaty resources from destruction.”

Francesca Mингrone, Staff Attorney, Climate & Energy Program at the Center for International Environmental Law (CIEL), said:

“The Special Rapporteur’s recommendation reflects growing acknowledgment by international bodies of the significant risks posed by the Line 5 pipeline, and the illegitimacy of the decision-making processes that have allowed the project to move forward without the meaningful participation and the free, prior, and informed consent of affected Indigenous communities. The report also makes clear that continuing to prolong fossil fuel dependence rather than advance an effective phase out is inconsistent with States’ climate obligations. The Canadian government must withdraw its support of Line 5, and ensure that affected Indigenous communities can effectively participate in any and all further discussions and decision-making processes around this pipeline and all other fossil fuel projects.”

Marco Simons, General Counsel, EarthRights, issued the following statement:

“This recent report confirms what Indigenous communities and human rights experts have told the government of Canada for years — Line 5 poses a direct threat to frontline communities in its path, and it violates the rights of Indigenous Peoples. Canada is obligated to regulate its companies, like Enbridge, to ensure the protection of Indigenous Peoples’ lands and way of life. Not only has Canada failed to do so, but it has also failed even to consult with — let alone obtain the consent of — affected Indigenous communities while it intervenes legally and diplomatically to ensure that Enbridge can operate Line 5 for decades to come. We call on the government of Canada to read this report and pull its support for Line 5.”



# SUICIDE AWARENESS

American Indian/Alaskan Native (AI/AN) communities experience higher rates of suicide compared to all other racial and ethnic groups in the U.S., with suicide being the eighth leading cause of death for American Indians and Alaska Natives across all ages. For Native youth ages 10 to 24, suicide is the second leading cause of death; and the Native youth suicide rate is 2.5 times higher than the overall national average, making these rates the highest across all ethnic and racial groups.

In 2021, non-Hispanic AI/AN people had a suicide rate 99% greater than the general population.

# Suicide Prevention and Care

## Community control

In a Canadian study of data from the British Columbia Coroner's Office, tribes with no suicides had more indicators of cultural continuity. Cultural continuity was defined as having infrastructure, such as the presence of cultural facilities, and sovereignty, such as self-government, having title to their traditional lands, and the provision of services within the community, including education, police, and fire; health care delivery; and child and family services.<sup>18</sup> In another Canadian study, preliminary evaluative data and Inuit community member narratives indicated that community control in designing and carrying out suicide prevention programming "can be effective towards preventing suicide."

## Cultural identification

Alaska Native tribal members following a more traditional way of life reported greater happiness, more frequent use of religion and spirituality to cope with stress, and less frequent use of drugs and alcohol to cope with stress.

Two studies of Native American youth in the Midwest found that those who had a stronger ethnic/cultural identity were better able to cope with acculturative stress and less likely to have suicidal thoughts.

## Spirituality

Commitment to tribal cultural spirituality (forms of spirituality deriving from traditions that predate European contact) is significantly associated with a reduction in suicide attempts. People with a high level of cultural spiritual orientation have a reduced prevalence of suicide compared with those with low levels of cultural spiritual orientation.

## Family connectedness

Connectedness to family and discussing problems with family and friends are protective against suicide attempts among AI/AN youth.




