A Simple Solution

A tool to protect informed consent and uphold a child's right to privacy. A Hatch letter in your child's file is a simple solution.

Under U.S. legislation and court decision, parents have the primary responsibility for their children's education, and students have certain rights that the school may not deny. Parents have the right to be assured that the schools do not unknowingly or knowingly impair or weaken the student's beliefs, moral values and belief systems within his or her family unit.

A student has the right to hold his or her values and moral standards without direct or indirect manipulation by the schools through curricula, textbooks, and AV material or supplementary assignments.

Under the Hatch Amendment, parents have the right to request that their child not be involved in any school activity nor introduced to material listed below unless they have first reviewed all the relevant material and given their written consent.



What is the Hatch Amendment?

We would like to address the issue of our vability to review classroom material via this letter.

Our desire is that we are able to review materials and address issues with our child concurrent with the curriculum and within the framework of our family, as well as having the appropriate knowledge to discern the curriculum's alignment or lack thereof with our family's beliefs.

Values clarification, use of moral dilemmas, discussion of religious or moral standards, role playing, open-ended discussions of situations involving moral issues, survival games including life/death decision exercises, contrived incidents for self-revelation, sensitivity training, group encounter sessions, talk-ins, magic circle techniques, self-evaluation, auto-criticism, strategies designed for self-disclosure including the keeping of a diary, journal or log book, sociograms, sociodramas, psychodramas, blindfolded walks, isolation techniques, death education including abortion, euthanasia, suicide, use of violence, discussions of death and dying, curricula or books and reading materials pertaining to religious beliefs (including elements of witchcraft), drugs and alcohol, nuclear war, nuclear policy, nuclear classroom games, globalism, one world government, curricula discussing antinationalistic views, evolution, discussion and testing on interpersonal relationship, discussions of attitudes towards parents and parenting, health education including human development, and education in human sexuality including birth control and pre-marital sex.

Psychological and psychiatric treatment or adult and peer counseling that is designed to affect behavioral, emotional or attitudinal characteristics of an individual or designated to elicit information about attitudes, habits, traits, opinions, beliefs, or feelings of an individual or group.



Note: There had been some relatively large shrinkages in the number of registrations in Indian River County earlier this year. Leslie Swan, the Indian River County Supervisor of Elections, provided information that the law was changed to make it easier to shift voters into the inactive voter category, a category where the process of removing the voter from the voter rolls is initiated. It appears that the bulk of the moves to the inactive category have been made as the number of registrations bottomed out in May.

The Phrasing and Branding Political Battle ©Stephen R. Meyer, Vero Beach

Those opposition to the building of greater amounts of owner-occupied homes are masterful in creating phrasing and branding. The controlling of the narrative through phrasing and branding has resulted in a shortage of housing for those wishing to purchase their first home.

Why promote home ownership? One reason is that the Federal Reserves' 2022 Survey of Consumer Finances found the net worth of homeowning households was \$396,200 versus a modest \$10,400 for those households who rent their housing!

A cause of the shortage of housing for the first-time home buyers is the decades old creation of what is referred to in Florida as the "urban service boundary". The inability to easily expand urban service boundaries has created a shortage of land available on which the building of starter homes may take place. Imposed shortages of land, coupled with the huge expansion in the demand for housing stemming from open-border policies and foreign buyers, along with large investment companies entering the housing market, has driven up home prices, pricing those wishing to purchase their first home out of the marketplace, while enriching landowners, existing homeowners, and local governments.

Urban is a word which is generally held in disdain. Urban is used throughout Florida statutes dealing with the creation of greater numbers of owner-occupied starter homes. For example, Florida Statue 163.3164 says, in part, in defining urban sprawl "...a development pattern characterized by low density, automobile-dependent development ...". Classifying "low-density development" as being urban is an amazing accomplishment for those whose intent is the inhibiting of the building of starter homes

Those who rent their housing, being far more likely to be registered as something other than Republican, explains the Democrats' reason for limiting the building of starter homes. What is the Republican reason? A good first Republican step would be to strip the word "urban" from Florida statues where "urban" is improperly used!

The Republican political class is often disconnected from the Republican rabble. A good way for the Republican rabble to determine who to vote for, especially for state and local offices, is a candidate's view on what is "urban"!
