TO RECUSE OR NOT TO RECUSE

Recusal is defined as follows: The legal process by which a judge, juror, or other adjudicator steps aside from participating in a case due to potential bias, conflict of interest, or appearance of impropriety. The word comes to us from Latin, like most legal terms - recusare "make an objection against; decline, refuse, reject; be reluctant to." The concept is an old one, but one that is fundamental to any democratic and judicial proceeding. It demands the highest standards of ethics of those empowered with decisions that affect the people. That's why even the appearance of a conflict or bias can trigger a requirement to recuse.

But the weak point in this process is that it usually requires self-identification. I looked through historical town council minutes and found numerous cases of council members and the mayor volunteering to recuse themselves from a debate and subsequent vote, due to a conflict of interest. However, I also found at least one example where recusal wasn't agreeable to all parties. In a town council meeting from 1984, one councilmember stated that "he felt Mr Austin should recuse himself from the matter" because "he had prejudged it." Mr Austin's response was that "he would not be brow beaten by any attorney or developer and would make notice in any manner he deems fit in his responsibility as an elected official." In other words, I'm not recusing myself! Most servants of the town are apparently willing to recuse themselves when necessary, but some are not. In the latter case, it may be necessary to force a recusal, and the town council certainly has the authority to do that by a vote.

From a citizen standpoint, recusal is what we expect when we elect you - we voters understand that you are involved in matters

What should the Town do with the 18 Court St Historic Asset?

In 1973, The Town of Warrenton purchased 18 Court Street, (across from the former Warren Green Hotel) and used it for years as a Town office until the Town purchased and refurbished the present Town Hall at 21 Main Street. Though 18 Court Street has since been used sporadically by the Town, it has largely remained unused for more than five years. Architecturally, it is a grand structure inside with high ceilings and second-story walkways overlooking the main hall.

Town residents should have a significant say in whether this building is retained or sold. While the County pursues the sale of the Warren Green Building to a company qualified to remodel and restore it as a historic hotel again, 18 Court Street is owned by the Town, not the County. Many citizens envision a public space for concerts, an art gallery or other space for promoting Old Town Warrenton. While the proposed buyer of the Warren Green building may want to also purchase 18 Court Street from the Town, the Town should seriously consider keeping this architectural asset and using it as a space for art, music and other public venues.

Ultimately, the Town Council should seek suggestions from citizens. Listen to and carefully consider the citizens' input. While the Town is in no financial position to continue incurring debt from a largely unused building, an ill-conceived plan for its use or a fire sale is indeed unwise.

Let the voters and the Council jointly decide on this building's future and not rush to a poor decision. This is a Town asset that once sold, is gone forever.



Several years ago, I listened to an interview in which Ryan Reynolds said his mother always taught him that it doesn’t cost anything to be nice. So simple, so profound, yet lost in a deluge of rhetoric where the anonymity of social media and a general lack of civility has fostered contempt, hatred, and a polarization of political views in American politics. I lived in a time when political discourse allowed all parties to “agree to disagree” while still working out a compromise. While not getting exactly what each party wanted, an agreeable compromise could be reached, acceptable to both parties. A compromise that contributed to the greater good of society. Is there any way we can get back to that approach to political engagement?

When this nation’s Founding Fathers crafted the Constitution, George Washington wrote a letter to the Congress of the Confederation of American States. He stated that the delegates had drafted a document that could unite the individual states into one nation:

"We kept steadily in our view, that which appears to us the greatest interest of every true American, the consolidation of our Union, in which is involved our prosperity, felicity, safety, perhaps our national existence. This important consideration, seriously and deeply impressed on our minds, led each state in the Convention to be less rigid on points of inferior magnitude, than might have been otherwise expected; and thus the Constitution, which we now present, is the result of a spirit of amity, and of that mutual deference and concession which the peculiarity of our political situation rendered indispensable." transmitting-the constitution. tinyurl.com/bfmfaw3

FASTA Key Note Speaker

Executive Director, Ester Daniel of Reset180 was the invited guest keynote speaker at the Candlelight Vigil held in the John Barton Payne building. Amelia Stansell (Fauquier Anti Sex Trafficking Alliance) considers Ester one of the FASTA partners. Paula Cruz from the Department of Social Services said that silence is a traffickers best ally. Traffickers and Domestic Violence takes place when a person is exploited by some vulnerability. Warrenton Police Chief Carter asked citizens to "trust your instincts;" Look for signs that a person is fearful or controlled. Ester says her mission involves a combination of all of these resources



working together. You can report a suspicion and then let the proper agency do the investigation. Prevent, Disrupt and Restore are the 3 pieces to achieve success. Prevention involves community awareness while disruption often deals with crises. Multiple agencies support the trafficked person, most often a girl. They do interact with the perpetrators and implementibg a juxtaposition of justice and mercy. Even the pastor from Dayspring Mennonite Church will participate in an active intervention by talking with the perpetrators. Ultimately, to restore the women and victims back to good mental health, a variety of resource are needed. "It is not inexpensive." Recently Jennifer Wexton has gathered one million dollars for a dedicated shelter for supporting victims. The evening ended with lighting candles and singing I'll Fly Away and Amazing Grace and a closing prayer from Keith McCullough from the Mount Zion Baptist Church.

But as I am at a point where I am thinking about retirement, I am considering what I might do with the extra time I expect to have. I also find myself thinking about my children and grandchildren. I have not participated much in local government. I have not felt compelled to engage in the debates over budgetary matters. I generally felt that common sense would prevail among the leaders of the Town of Warrenton and decisions would be made that served the greater good.

6 figure job for participating? Recently, Ms. Brandie Schaefer helped rezone the AMAZON data center on Hwy 29 and Broadview Avenue in Warrenton. Brandie was the former Warrenton Town Manager and quickly resigned her post to accept a position at Amazon Web Services. In a Prince William Times article from August 5th 2022 entitled, "**Fauquier County Board Chair to resign after his spouse, the former Warrenton town manager, takes a job with Amazon**" [tinyurl.com/bdfaykks](https://www.tinyurl.com/bdfaykks)

Coy Ferrell Fauquier Times Staff Writer Aug 5, 2022, wrote Brandie is stepping down due to "strain". Ironically, on the same page, a link has been inserted to take you to an article titled, "**Data centers' secrecy often keeps residents in the dark**" by Peter Cary Piedmont Journalism Foundation. Perhaps this is the strain Brandie was talking about? Under the notorious lock down, Warrenton residents were kept in the dark until after the deal was done. Concerned citizens should KEEP AN EYE on the Town Managers to make sure they aren't keeping us in the dark.

"The Frost Diner makes more money for the town in a year than a data center ever will," was a recent comment made by a decades long Warrenton resident and council member from 30 years ago to me at the grocery store. I told him that I'd like to see a 4-star hotel with architectural designs that match the town's character with conference rooms and wedding venues. He said he suggested that for the very spot the AWS data center was slated for. This would bring well needed tourists to visit our town and businesses.

Data centers present a pretty package with shiny bows but the values are never realized and they leave an ugly mark. Put the data centers in already designated zones and stop trying to enter small towns with nefarious secretive dealings that reward favors to those who bend the rules. The mayor's actions are shameful and at best varying the lead. He pretends to have one explanation but then it changes up. 

Recently, at the December 2025 Regular Meeting of the Town Council, a topic regarding the operational budget became a little convoluted and resulted in pointing fingers and misdirected accusations. The bottom line is "who pays" for the WARF negative budget bottom line. Further, who has been covering the deficit for the last 14 years; tax payers, neighbors, WARF members, docents, bank loans? Regardless of how much we love and want this asset in our small town, we must be responsible in how it gets accounted for as a Town of Warrenton expense.

Fauquier Leaks and Fauquier Forward social media sites had posted information that seemed to lead people to believe that specific Town Council Members wanted to close the WARF. Wanting a low cost recreational facility is much different than budgeting for it. The truth behind

A SEMPLE Request from the Town Council to Town Residents

As of the January Town council meeting several topics were discussed that are directly related to the Warrenton Town budget; including the passing of a debt-funded water and sewer infrastructure which involves Bonds to total 90 MILLION dollars with the first "tranche" of money set at 16 Million dollars. Additional discussion of the WARF annual budget shortfall is concerning. In closing remarks Town Council Member Bill Semple asked all residents to familiarize themselves with the Warrenton Town Budget right now. He explained that often people start participating too late in the process or after it is passed. Town Council member, Eric Gagnon, after written attacks on social media by anonymous contributors that Eric was trying to shutdown the WARF, explained his actions at the December meeting. Following an angry scolding and outcry from people who read this information, Eric stated that he doesn't have a side on how to pay for the deficit, but has a duty to be transparent to the residents regarding the budget; raise property taxes, take out annual loans, or alternatives.







VERY CRAFTY CREATIONS




